### SUSPENSION OF STANDING ORDERS

An tArdmhéara advised An Chomhairle that notification of intention to suspend standing orders has been received and called on Comhairleoir M. Nugent to read his and Comhairleoir K. Collins motion:-

'That Cork City Council write to Ministers Michael McGrath, Roderick O'Gorman, Pobal and the HSE to determine if funds are to be made available to assist Northside Community Enterprises (NCE) to re-open the Before 5 Family Centre in Churchfield.'

On the proposal of Comhairleoir M. Nugent, seconded by Comhairleoir T. Fitzgerald, An Chomhairle agreed to suspend standing orders to take the motion.

### SUSPENSION OF STANDING ORDERS

On the proposal of Comhairleoir P. Dineen, An Chomhairle agreed to suspend standing orders to discuss the following motion at the end of the meeting:-

'I ask that this Council calls on the Minister for Justice Miss. Helen McEntee and the Department of Justice to set in motion negotiations or the framework and funding required that will allow for the re-establishment of the Support After Crime Services in Cork City. The service which was widely used by the Victims of Crime was regrettably and unfortunately lost to our City in January of this year. The Support After Crime Service is an essential tool required by the victims of crime to deal with their trauma their loss and their ability to come to terms with what has happened to them following a crime been brought to bare upon them.

Our current Justice System leans immensely in favour of the Perpetrator of Crime, and it is therefore creating a CRIME PAYS policy in Ireland and this needs to change with immediate effect. With that said and following the incoming Taoiseach's comments at the Fine Gael Ard Fheis on Saturday 6<sup>th</sup> April stating that he supports Law & Order and that he wants tougher sentences, he wants to increase Prison capacity and he wants to address knife crime and Anti Social Behaviour. His intentions are welcome and I know we all support this but he did mention in the same statement [Heinous Criminals]. But yet all too often it is the small time persistent criminal that effects the people the most therefore I further ask that this Council calls on the Minister for Justice Miss Helen McEntee TD, An Taoiseach Simon Harris TD, An Tánaiste

Micheal Martin (TD for Cork South Central), the Minister for Finance Micheal McGrath (TD for Cork South Central), and the current Minister for Trade Enterprise and Employment Simon Coveney (TD for Cork South Central) to initiate an overall review of our Judicial approach to Criminality and the supports provided therein including the Free Legal Aid System that support criminals and to introduce a more robust structure that provides less supports for criminals and more supports for the Victims which should include advisory supports, compensation for the victims of crime and financial retribution from the Perpetrator for the Victims of Crime.'

## 6. **QUESTION TIME**

## 6.1 **NUMBER OF CONSTRUCTION CONTRACTS**

The following question submitted by Comhairleoir K. Collins was deferred to the next meeting of An Chomhairle to be held, 13<sup>th</sup> May 2024:-

To ask the CE to report, by company, the current number of construction contracts open and the cumulative value of same over the last five years in tabular form by company.

### 6.2 CEOL TRADITIONAL MUSIC & CULTURE EXHIBITION

The following question submitted by Comhairleoir K. O'Flynn was deferred to the next meeting of An Chomhairle to be held, 13<sup>th</sup> May 2024:-

Please update the Council on the prestigious Ceol traditional music and culture exhibition that was purchased by the Council under the 2006/2007.

Could you please provide information on the current whereabouts of this collection and how it is being stored? Additionally, the state of preservation of this collection and what measures have been taken to ensure its pristine condition since the day of purchase.

Furthermore, provide details on the total cost of acquiring this exhibition and the estimated storage costs incurred by the city.

Finally, could you please outline any future plans regarding the exhibition's return to the public domain?

### 6.3 <u>KILLOWEN ROAD RESURFACING</u>

In response to the following question submitted by Comhairleoir B. McCarthy, a written reply was circulated as outlined below:-

The part of Killowen Road from the school to McPolins Avenue was resurfaced with drainage and gullies 2 years ago. These were the first two sections but Section 3 still hasn't been done. There is a heavy volume of traffic including HGV vehicles from Blarney Village to Courtbrack and when it rains the water flows down the hill and into the resident's entrance as there are no drains or gullies. When is the work on Section 3 going to be completed?

#### **REPLY**

This is a rural location with significant ribbon development, where there has never been a piped surface water sewer system. The cost of installing such a system together with the resurfacing of the road, lining and signing is estimated at over €400,000. Funding needs to be identified to carry out these works. In the interim, Cork City Council will continue to carry out routine remedial maintenance as necessary.

Can the CE please advise why the **Glanmire Garda Station** is only open on a part time basis. With the ever increasing population of Glanmire and surrounding areas, this relatively recently opened Garda Station urgently needs to be opened on a Full time basis and adequately resourced in order to provide a much needed Garda service to this rapidly growing Community in our City.

### **REPLY**

Any enquiry relating to the operation of An Garda Siochana is a matter for the senior management of An Garda Siochana. This motion is better addressed to the Joint Policing Committee. Any such motions should be directed to the Garda District Management Committee or to the Chair of the JPC seeking inclusion on the agenda of the next meeting.

### 6.5 **DPG APPLICANTS**

In response to the following question submitted by Comhairleoir K. Collins, a written reply was circulated as outlined below:-

Can the CE provide, in tabular form, the number of DPG applications currently approved but not commenced for installation of a downstairs toilet and bedroom and ramp access, the average wait time for same in 2023, the number of transfers currently approved on medical grounds due to a requirement for a downstairs toilet and bedroom and ramp access and the longest any applicant currently eligible for such a transfer has been approved for same.

#### **REPLY**

The Housing Delivery and Regeneration Directorate currently has 6 no. home extension projects not commenced, for Accommodation of Persons with a Disability, as per the following table, which notes the length of time of placement on the property extensions programme. This is an annual programme and the Directorate has successfully completed 77 no. extensions for Accommodation of Persons with a Disability in the last five years. The procurement process is to commence shortly for the 2024 programme.

The Housing Operations Directorate currently has 83 applicants (either Council tenants or tenants of an Approved Housing Body) who have transfer applications open with a Basis of Need recorded as "Disability Requirement – physical". It is not possible without a more detailed interrogation of the list to determine the number who specifically have a requirement for a downstairs bedroom and bathroom. Applicants would not be noted as having a requirement for a ramp but would instead be recorded as needing level access accommodation.

It should be noted that the process of classifying medical or disability needs has become more streamlined with the introduction of the HMD-Form 1 in October 2021,

thus allowing for greater accuracy in identifying an applicant's housing requirements. The Housing Welfare Officer also assess and provides welfare reports on the cases that are identified as the most severe or urgent.

It is important to note that offers of alternative accommodation based on medical or disability needs are prioritised on the basis of the urgency of need not solely on the length of time an application has been open. For example, a tenant who cannot be discharged from hospital due to the unsuitability of their current accommodation would be considered an urgent case for re-housing.

In addition to having specific accommodation requirements relating to their medical condition, applicants will also have identified specific areas in which they wish to live. Applicants can be considered for suitable properties they bid on through the CBL system and their disability requirement is highlighted on the bid list reviewed by the Allocations Officer. However, for specially adapted properties or bungalows allocated outside the CBL system, matching a suitable property with the applicant's area of choice can significantly limit our ability to meet their needs in a timely manner. While an applicant's transfer may remain open for a longer period, this is often due to offers of alternative accommodation being refused or where the household circumstances have changed since their original application was approved resulting in their requirements being revised over that period.

### 6.6 **ROSSA AVENUE**

In response to the following question submitted by Comhairleoir O. O'Leary, a written reply was circulated as outlined below:-

With the increased footfall and traffic through Rossa Avenue in recent years, this has put considerable pressure on the road and also the drainage system. City Council staff have frequently carried out work on Rossa Avenue such as filling individual potholes or repairs to the drainage mains. Can the CE report on assessments that were undertaken and outline what long term measures the Council will take to address the issues to the road and the drainage system?

### **REPLY**

I can confirm that in recent weeks maintenance works have been undertaken on the following public infrastructure on Rossa Avenue:

- 1) A break in a foul pumping/rising main was repaired
- 2) Potholes were filled along the road carriageway
- 3) Road gullies which were blocked were cleaned out

Cork City Council will continue to address general maintenance issues as they arise/are reported.

### 6.7 **MODULAR/RAPID BUILD HOUSING**

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the CE report on the City Council's modular/rapid build housing element of its social housing programme, the number & type of units involved & if there are further developments proposed?

#### **REPLY**

Cork City Council is currently progressing two pilot projects through Modern Methods of Construction, for apartment developments which have been particularly designed with a view to enable the use of 3D modular structural systems and elements, or alternatively 2D structural systems. The projects will provide 133 new homes, and are located at Westside, Model Farm Road (43 homes) and Cloverhill Court, Bessboro Road (90 homes). Both projects have received Part 8 planning approval and are at final tender stage, with construction projected to commence in Q2/Q3 of 2024, with completion in 2025.

The Directorate is also currently considering other rapid build, modular housing solutions within the housing delivery programme, and we have identified a possible additional pilot project. This is currently at feasibility stage but is proposed to be progressed as a rapid build modular project in 2024.

## 6.8 **CBL**

In response to the following question submitted by Comhairleoir O. Moran, a written reply was circulated as outlined below:-

To ask the Chief Executive to clarify if refusal of a bid property under CBL affects the reckonable period for the purposes of determining the relative priority of a household for social housing; and the relevant regulations or section of the allocations scheme that states this.

### **REPLY**

When a property is advertised on the CBL system an applicant has a period of 1 week to place a bid. An applicant can withdraw their bid anytime during this period, but once the bid week is closed any bid made is deemed to be valid. The refusal of an offer made following a bid on CBL results in a deferral period of 1 year being applied.

During this period an applicant cannot be considered for another property. The period of the deferral is also not counted towards the applicant's credit time. The impact of a refusal is clearly stated on the CBL system when an applicant bids on a property and an applicant must confirm they wish to proceed with a bid following this warning. When the deferral period has ended, the applicant's credit time prior to the deferral is restored to them and any prioritisation previously awarded to them is reinstated.

It should be noted that there is an Appeals Process in place whereby an applicant can appeal a deferral applied following a refusal. Applicants are advised on the letter which issues applying a deferral how to submit an appeal. The initial appeal is reviewed by the Senior Executive Officer, Housing Operations and following the outcome of this appeal, a further appeal can be submitted to the Director of Services, Housing Operations.

S.I. No. 198/2011 – Social Housing Allocation Regulations 2011 is the relevant legislation. In particular Section 12(2) states "and the latter period shall not subsequently be reckonable in any way for the purposes of determining the relative priority of that household for a dwelling allocation".

Section 3.8 of the Allocation Scheme outlines the Refusal Policy & Section 3.10 refers to Choice Based Letting.

# 6.9 <u>COMPULSORY PURCHASE ORDERS ON PROPERTIES LISTED ON</u> <u>DERELICT SITES REGISTER</u>

In response to the following question submitted by Comhairleoir D. Boyle, a written reply was circulated as outlined below:-

To ask the Chief Executive the number of Compulsory Purchase Orders used, since June 2019, on properties listed on this Council's Derelict Sites Register?

### **REPLY**

In the period from June 2019 to date, Cork City Council issued notices regarding the compulsory acquisition under the Derelict Sites Act 1990 on 17 properties. Twelve are fully vested in Cork City Council and the remainder are at various stages of the process, one having recently commenced, one was subject to a court order and has since been sold and three are currently with An Bord Pleanála (ABP) on foot of objection to the compulsory acquisition and the ABP decision is awaited.

### 6.10 DATA COLLECTION OF WALKING & CYCLE RATES

In response to the following question submitted by Comhairleoir C. Finn, a written reply was circulated as outlined below:-

Can the CE give an update on the data being collected of walking & cycle rates and if there are monitors in population growth areas eg Ballincollig.

#### **REPLY**

Data in relation to pedestrian numbers is collected by the City Council on the City centre island at eleven sites (i.e., St. Patrick's Street at the junction with Grand Parde x2, St. Patrick's Street at the junction with Academy Street x2, St. Patrick's Street at the junction with Merchants Quay x2, Caroline Street, Pembroke Street, Princes Street, Beasley Street and Union Quay). This data is compiled weekly, and monthly trends are recorded.

Annually a traffic count, that includes cyclists, is also undertaken. Inner/mid City and outer City cordon counts are undertaken on alternate years.

The Council also undertakes regular turning surveys at major junctions across the City. The junction data collected (bus, car, taxi, LGV, HGV, motorcycle and cycle) is used to support the development of capital projects.

Presently an NTA funded pilot project is underway to install cycle detection at locations in the city centre area that includes a facility to collect data. Verification of the information being collected is under way as part of the commissioning process.

2. Disposal of three sites within the residential development of Newton Heights, Boherboy Road, Lotamore, Mayfield, Cork to Clúid Housing, c/o Byrne Wallace Solicitors, 88, Harcourt Street, Dublin D02 DK18, County Dublin, for the sum of €926,160.00 (inclusive of VAT).

3. Disposal of an area of ground (237.8 m² approximately) located to the rear of No. 118, Uam Var Drive, Bishopstown, Cork to Nóirín Moynihan c/o, Babington, Clarke & Mooney Solicitors, 48, South Mall, Cork for the sum of €500.00 plus costs of €1,500.00, plus VAT.

4. On the proposal of Comhairleoir D. Cahill, seconded by Comhairleoir T. Shannon, An Chomhairle further agreed to adopt the following Resolution:-

"Resolved that, pursuant to the provision of Section 6 of the Housing (Miscellaneous Provisions) Act, 1992, a loan facility not exceeding €263,068.34 be granted to Cork Simon Community CLG, subject to the terms of the Capital Assistance Scheme for the provision of 1 one bed unit of accommodation at 106 Ardkeale, Mount Oval Village, Rochestown, Cork."

# 7.3 <u>CAPITAL ASSISTANCE SCHEME: APARTMENT 8, TRINITY COURT, WHITE STREET, CORK - CORK SIMON COMMUNITY CLG</u>

An Chomhairle considered and approved the report of the Director of Services, Housing Delivery & Regeneration dated 20<sup>th</sup> March, 2024 in relation to a loan facility for Cork Simon Community CLG in respect of the provision of one unit of accommodation at Apartment 8, Trinity Court, White Street, Cork.

On the proposal of Comhairleoir S. Martin, seconded by Comhairleoir D. Boyle, An Chomhairle further agreed to adopt the following Resolution:-

"Resolved that, pursuant to the provision of Section 6 of the Housing (Miscellaneous Provisions) Act, 1992, a loan facility not exceeding €233,278 be granted to Cork Simon Community CLG, subject to the terms of the Capital Assistance Scheme for the provision of 1 one bed unit of accommodation at Apartment 8, Trinity Court, White Street, Cork".

## 7.4 **DRAFT 2024 STREET PERFORMER BYE-LAWS**

An Chomhairle considered and approved the Bye-Laws for adoption with amendment.

On the proposal of Comhairleoir D. Boyle, seconded by Comhairleoir K. O'Flynn, An Chomhairle further agreed to adopt the following Resolution:-

- "Now therefore it is hereby resolved that the Draft 2024 Street Performer Bye-Laws made by Cork City Council for the control and regulation of street performers within the City of Cork are approved with the following amendments:
- 1) The wording of Section 3 is changed from:
- 'A person may apply for and be granted a Street Performance Permit upon completion of the requisite application form for a Permit and payment of the fee.'

To:

- 'A person must apply for and may be granted a Street Performance Permit upon completion of the requisite application form for a Permit and payment of the fee. This fee is waived for those aged under 25 years. '
- 2) The term "Visitor Street Performance Permit" contained within Section 3(b) and Section 4(a) is changed to "Short-Term Street Performance Permit"

The new Bye-Laws shall come into force and effect on the 20<sup>th</sup> day of May 2024, being not less than 30 days after the Council meeting adopting and making these bye-laws, in accordance with the provisions of section 200(5)(a) of the Local Government Act, 2001.

### 13.2.2 **GRAFFITI IN CORK CITY**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 13<sup>th</sup> March 2024 on the following motion:-

'That Cork City Council put in place a plan to clean up many areas of our City streetscape which is currently horribly defaced with various types of Graffiti. Tourists visiting our City as well as residents of our City are continually appalled at the growing levels of this disgraceful levels of horrendous Graffiti on public facades of buildings in the City. This is a form of littering which defaces the public streetscape in a very negative way.

In order to prevent the growing levels of Graffiti in public places, maybe the implementation of CCTV monitoring and a policing strategy put in place could endeavour to get the scourge of Graffiti under control. This Graffiti is generally applied by individuals with little or no concern or pride for the beauty and general maintenance of our wonderful City.'

(Proposers: Cllr. J. Kavanagh, Cllr. D. Cahill 24/043)

The report of the Director of Services stated that Cork City Council is aware of the graffiti which has occurred across the city. The Council acknowledges that this type of anti-social behaviour is very distressing and upsetting for both residents and business owners. Graffiti is not a victimless crime as property owners are directly affected by this unacceptable behaviour. Under the Litter Pollution Act 1997 it is the property owners who are responsible for the removal of the graffiti from their premises which can be both costly and time-consuming.

Cork City Council, in conjunction with the Probation Service, operate a programme of graffiti removal, which either removed or painted over, on public premises and public infrastructure. As the Probation Service has limited resources, this service is focused on public or problematic buildings. The responsibility to clean graffiti off of privately owned buildings (residential or business) rests with the property owner.

Defacement of property is a criminal act and the City Council has no role in the apprehension or prosecution of those involved in such activity. In such situations the use of CCTV is ineffective as defacement of property by graffiti is generally carried out in darkness and by individuals who wear head coverings such as hoodies so that their identities cannot be identified from CCTV images. Cork City Council will bring the concerns raised in this Motion, regarding the request for a policing strategy to tackle graffiti, to the attention of the Gardai.

#### 13.2.3 POLICY TO ENCOURAGE BUSINESSES TO REMOVE SINGLE USE CUPS

An Chomhairle considered and approved the report of the Interim Director of Services, Community, Culture & Placemaking, dated 13<sup>th</sup> March 2024 on the following motion:-

### 20.1.1 SPEEDING TRAFFIC ON BALLYHOOLY ROAD

An Chomhairle considered and noted the report of the Director of Services, Operations, dated 26<sup>th</sup> February 2024 on the following motion:-

'On behalf of the residents of Ballyhooly Road, I wish to bring to the attention of the Council, the very grave issue of speeding traffic in the area.

In particular, I highlight the following priorities to be addressed as a matter of urgency:

- 1. A reduction of the speed limit to 30 km per hour.
- 2. Signage to indicate this speed limit.
- 3. Signage to indicate that this is a residential zone.
- 4. Signage to indicate that there are children crossing.
- 5. Signage to indicate that this is a school zone.
- 6. Signage to urge drivers to reduce speed.
- 7. Appropriate traffic calming measures.
- 8. Solar powered speed monitors.'

(Proposer: Cllr. T. Tynan 24/063)

The report of the Director of Services stated that Ballyhooly Road will be added to the list of areas to be considered for inclusion in the next phase of 30kph speed limit byelaws to be brought forward to Members.

In relation to signage, Cork City Council will assess the request for new signage. Any works deemed appropriate will be added to the roads programme and undertaken subject to priorities and available resources.

In relation to traffic calming, requests for traffic calming are recorded by Traffic Operations and Ballyhooley Road has been added to the list of requests. Annually Roads Operations bring forward to the Members of the Area Committees all requests for traffic calming and locations are selected by the Members subject to funds being available.

The quantum of infrastructure that is installed annually is directly proportional to the amount of funding provided to the Operations Directorate for such purposes. As such,

should Members wish to increase the pace of delivery of Traffic Calming Infrastructure then options to achieve same are a) increase the revenue budget allocation in 2025 or b) assign some of the 2024 LAC Budget towards such works.

It should be noted that Ballyhooley Road is listed on the BusConnects programme as a Strategic Transport Corridor which will by it's nature provide many traffic calming features in the medium to long term.

### 20.1.2 **30 KM PER HOUR SPEED LIMIT ON LOWER GLANMIRE ROAD**

An Chomhairle considered and noted the report of the Director of Services, Operations, dated 26<sup>th</sup> February 2024 on the following motion:-

'I am calling on Cork City Council to impose a 30 km per hour speed limit on the Lower Glanmire Road, as a matter of urgency.

The residents of the area have reported that they find it extremely difficult and dangerous to cross the road, even at crossings operated by pedestrian lights. The location is a residential area.

A 30 km per hour speed limit would help make the road safer, calmer and reduce both air and noise pollution in the local area.'

(Proposer: Cllr. T. Tynan 24/064)

The report of the Director of Services stated that the N8, Lower Glanmire Road is classified as a National Road. Transport Infrastructure Ireland (TII) are responsible for the operation and development of national roads in Ireland. TII are required to carry out a review of speed limits on National Roads on at least a five yearly basis. (Guidelines for setting and managing speed limits in Ireland) The current review will result in draft byelaws being published for consultation in 2024. Your request will be referred to TII for assessment in the next review.

### **SUSPENSION OF STANDING ORDERS**

'I ask that this Council calls on the Minister for Justice Miss. Helen McEntee and the Department of Justice to set in motion negotiations or the framework and funding required that will allow for the re-establishment of the Support After Crime Services in Cork City. The service which was widely used by the Victims of Crime was regrettably and unfortunately lost to our City in January of this year. The Support After Crime Service is an essential tool required by the victims of crime to deal with their trauma their loss and their ability to come to terms with what has happened to them following a crime been brought to bare upon them.

Our current Justice System leans immensely in favour of the Perpetrator of Crime, and it is therefore creating a CRIME PAYS policy in Ireland and this needs to change with immediate effect. With that said and following the incoming Taoiseach's comments at the Fine Gael Ard Fheis on Saturday 6th April stating that he supports Law & Order and that he wants tougher sentences, he wants to increase Prison capacity and he wants to address knife crime and Anti Social Behaviour. His intentions are welcome and I know we all support this but he did mention in the same statement [Heinous Criminals]. But yet all too often it is the small time persistent criminal that effects the people the most therefore I further ask that this Council calls on the Minister for Justice Miss Helen McEntee TD, An Taoiseach Simon Harris TD, An Tánaiste Micheal Martin (TD for Cork South Central), the Minister for Finance Micheal McGrath (TD for Cork South Central), and the current Minister for Trade Enterprise and Employment Simon Coveney (TD for Cork South Central) to initiate an overall review of our Judicial approach to Criminality and the supports provided therein including the Free Legal Aid System that support criminals and to introduce a more robust structure that provides less supports for criminals and more supports for the Victims which should include advisory supports, compensation for the victims of crime and financial retribution from the Perpetrator for the Victims of Crime.'

On the proposal of Comhairleoir P. Dineen, seconded by Comhairleoir K. O'Flynn, a vote was called for on the approval of the motion where there appeared as follows:-

**ABSTAIN:** Comhairleoirí T. Tynan, O. Moran, J. Sheehan, T. Shannon. (4)

As those voting in favour were greater than those voting against, and the vote was carried by a 2/3 majority as prescribed in standing orders, An tArdmhéara declared the vote carried, and the motion approved.
