#### 53.1 FLOOD WATERS ON CENTRE PARK ROAD

In response to the following question submitted by Comhairleoir K. McCarthy, a written reply was circulated as outlined above.

To ask the Manager why the floodwaters on Centre Park Road in February's floods were not dealt with and pumped away in the aftermath of the flooding events; it left many businesses struggling to get customers in for well over a week on Centre Park Road?

#### **REPLY**

Tidal flooding occurred in the City Centre on the night of the 4<sup>th</sup> February, and extended onto Centre Park Road. No complaints of issues flooding on Centre Park Road were received on 5<sup>th</sup>. A communication was received from Cllr McCarthy on the 6<sup>th</sup> and investigated. The Roads Section carried out cleaning of road gullies on that day. Gully cleaning was also carried out on the 10<sup>th</sup> and 17<sup>th</sup> of February.

Dissipation of surface water from the Centre Park Road area is via road gullies connected to piped waterways located in adjacent private lands. The waterways are not in the control of, or maintained by the City Council.

Discussions have been initiated recently, between the land owners and the City Council, to explore development of a partnership approach to improving the surface water system in the area.

## 53.2 ROAD SAFETY AND HEALTH SAFETY AT BUXTON HILL, SUNDAY'S WELL

In response to the following question submitted by Comhairleoir T. Fitzgearld, a written reply was circulated as outlined above.

To ask the Manager to implement the proposed suggestions from the residents at Buxton Hill, Sunday's Well in the interest of road safety and health safety for motorists and residents in the area:

- a) The installation of a convex mirror on the lamppost opposite the bottom of Buxton Hill, as used in other locations both in an outside the city, to enable drivers to be fully aware of traffic and to be able to exit and enter Buxton Hill with safety, and
- b) Erection of clear signs and painting road markings on the Sunday's Well Road to warn road users of a hidden junction when approaching Buxton Hill both from the east and the west.

#### **REPLY**

The Transportation Division advises that whilst convex mirrors can help to eliminate safety hazards in areas where visibility is limited, it is essential, that the mirror is sized, installed and used correctly in order to judge how near or far away an approaching person or vehicle is. If the convex mirror is too small or the car is not within the maximum observation distance from the mirror, it may in fact hinder traffic safety. For that reason, Cork City Council does not support the provision or installation of convex mirrors as a means of improving road safety in places with limited visibility.

The Transportation Division recognises the difficulty posed by persons accessing Buxton Hill and the area will be assessed to identify any possible mitigation measures that can be provided there. Any identified solutions will be put forward for consideration to be included in the Roads Programme, subject to funding being available.

#### 53.3 CURRAHEEN ROAD FROM CURRAHEEN ESTATE

In response to the following question submitted by Comhairleoir M. Shields, a written reply was circulated as outlined above.

When cars are parked east of the above junction it is very difficult for motorists to have a clear vision in order to exit on to Curraheen Road from Curraheen Estate. I am proposing that the double yellow lines be extended in the interest of safety.

#### **REPLY**

The Transportation Division advises that the intersection of Curraheen Road and Curraheen Estate will be assessed in order to identify the extent of the problems that exist there and also to identify the most appropriate measures that can be provided.

Any identified measure will be put forward for consideration to be included in the Roads Programme, subject to funding being available.

## 53.4 HOW MANY STAFF WILL LOSE THEIR JOBS IN CORK CITY COUNCIL DUE TO THE FORMATION OF THE NEW WATER AUTHORITY

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined above.

Can the Manager confirm how many staff will lose their jobs in Cork City Council due to the formation of the new Water Authority?

What compensation will accrue to Cork City Council for the decades of investment in the water network and infrastructure?

Can the Manager confirm that the life span of water meters is 7 to 10 years and therefore the installation of water meters would be an ever ending programme with an ever ending cost to the tax payers?

#### **REPLY**

The Minister for Environment, Community and Local Government has indicated the provision of funding for redundancies in Local Authorities associated with the development of Irish Water. At this time there is no indication where workforce reductions are going to occur. Currently it is not possible to forecast how many job losses or indeed if any job losses will occur in Cork City Council during the twelve year life of the Service Level Agreement with Irish Water.

In transferring assets to Irish Water no provision has been made for compensating or recouping to the Local Authorities, Central Exchequer or EU for the investment made in the Water Services infrastructure in place.

As with all mechanical and electrical equipment used in the provision of water services, meters will require regular maintenance and a renewal programme.

The cost of maintaining and renewing water meters has, presumably, been taken account of in the assessment of the charging mechanism and the quantum has been balanced with equity and conservation needs. Clarification or justification in this regard can be sought from Irish Water and the Regulator.

## 53.5 STONE WALL OPPOSITE THE PHOENIX KAYAK CLUB ON THE LEE ROAD

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined above.

Can the Manager tell me if there are plans to repair the stone wall opposite the Phoenix Kayak Club on the Lee Road damaged in the storm in mid-February and which buried the footpath in the process? Will further works be carried out on repairing footpaths in the Lee Road area which are in a poor condition and a general hazard to the public? Will Cork City Council work with the County Council to ensure works are carried out where necessary?

#### **REPLY**

The wall in question lies within Cork County Council's area and is therefore a matter for that Council. The footpaths within Cork City Council's section of the Lee Road will be inspected and any necessary repairs will be carried out in the coming months.
