3. **LORD MAYOR'S ITEMS**

3.1 **ITEM 9.1 LOWER LEE (CORK CITY) DRAINAGE SCHEME**

On the proposal of the Lord Mayor, Comhairleoir D. Cahill, An Chomhairle agreed to consider item 9.1 under Lord Mayor's Items.

An Chomhairle considered and approved the Draft Report on the Council's response to the OPW Lower Lee (Cork City) Drainage Scheme, with the following amendments:-

- (i) Reserve the right to make a further submission should additional information become available at a later date.
- (ii) To include reference to retaining the historic railings at the North Mall, Sullivan's Quay and St. Patrick's Quay.
- (iii) Strengthen the reference to dredging

On the proposal of Comhairleoir S. Martin, seconded by Comhairleoir T. Moloney, An Chomhairle further agreed to adopt the following resolution:-

"That in accordance with Section 5 (2b) of the Arterial Drainage Act 1945, and having examined and considered the Lower Lee (Cork City) Drainage, that we resolve to submit this Report to the OPW as the City Council's submission in relation to the Scheme".

6. **QUESTION TIME**

6.1 **UPDATE ON MOTIONS 15/210 AND 15/289**

In response to the following question submitted by Comhairleoir P. Dineen, a written reply was circulated as outlined below:-

Can the CE update me on the following motions (15/210) Car Park at the junction of Summerhill South, Langford Row and High Street and (15/289) include Father Mathew Road, Turners Cross in the reconstruction and resurfacing programme .

These motions were submitted in good faith in 2015 and both were to be assessed at that time. However, no works or improvements have been carried out at either location to date.

REPLY

The car park at the junction of Summerhill South, Langford Row and High Street was recently upgraded with the installation of traffic delineators and a yellow box. This work

provides for orderly parking and protection for the adjoining residential property. The car park and surrounding area has also been the subject of additional patrols by the traffic warden service to ensure that the available spaces are used in a compliant manner and to address the issue of abandoned vehicles. With regard to the proposed conversion of the green area to parking there was been no provision in the adopted annual budget for such works. However, this proposal can be considered further when such funding is provided in future. The agreement of all the residents affected by the proposal will be necessary for same. Where budgetary provision is made for this type of work, related proposals are generally the subject of discussion and agreement at Ward level similar to traffic calming works.

Fr Matthew Rd, Turners Cross was assessed and considered, in conjunction with other roads within the City, for surfacing works under the annual surfacing programme. As Members will be aware the amount of surfacing work that can be undertaken each year is limited by the funding available and works have to be prioritized accordingly. The roadway will be examined along with others in the context of future programmes and in the interim any necessary temporary repairs will be effected.

6.2 **UPGRADE WHITE STREET CAR PARK**

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

Has Cork City Council any plans to upgrade White Street Car Park and enhance the environment of the area?

REPLY

The City Council has proposed plans to upgrade the car park site and neighbouring sites. The proposals if implemented will enhance the environment of the area and provide sustainable urban development in White Street. The site is zoned as part of the Inner City Residential Neighbourhood and this zoning seeks “to reinforce the residential character, while supporting the provision and retention of local services, and civic and cultural institutions” (ZO3: Inner City Residential Neighbourhood, CDP2015-2021, p226).

It is proposed to proceed with a social housing development at this location as the major plank of this regeneration initiative. The proposed development would improve the public realm and provide an attractive and desirable living environment in this convenient City Centre location and is in keeping with Council policy to increase residential supply in City Centre locations. Pre Part 8 planning consultation has been carried out within the Council and with the local elected ward members.

The next step is to identify any outstanding environmental issues that need to be addressed and implement any measures deemed necessary as a result of this exercise.

An Chomhairle considered and noted the minutes of the Housing & Community Functional Committee from its meeting held 20th March 2017.

11.1 **DISPOSALS**

An Chomhairle considered and approved the report of the Chief Executive dated 16th March 2017, in relation to the following property disposal:

- a. Disposal of freehold interest in the property known as No. 74, Tory Top Road, Ballyphehane, Cork to John and Marie Roache, c/o M/S Comyn, Kelleher, Tobin Solicitors, No. 2, George’s Quay, Cork for the sum of €5,500.00 (plus VAT if applicable) together with costs in the sum of 1,500.00 (plus VAT).

11.4 **CHOICE BASED LETTING SCHEME – THE ADDITION OF APPROVED HOUSING BODY PROPERTIES**

An Chomhairle considered and noted the report of the Director of Services, Housing & Community Services, dated 16th March 2017, in relation to the Choice Based Letting Scheme – the Addition of Approved Housing Body Properties.

11.5 **CHOICE BASED LETTING SCHEME – MONTHLY UPDATE**

An Chomhairle considered and noted the report of the Director of Services, Housing & Community Services dated 16th March 2017, in relation to an update on the Choice Based Letting Scheme.

11.6 **RODENT PROBLEM IN DEERMOUNT**

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 16th March, 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council investigate the source and cause of the rodent problem in Deermount and ensure that all residents are engaged with to ensure that there is no reoccurrence of the problem.’

(Proposer: Cllr. S. Martin 17/018)

The report stated that in response to the issue, the Housing Maintenance Section engaged with Cork Drain Ltd. to carry out a survey of houses in Deermount. Damaged drains were detected and are being repaired. There was a meeting of the Deermount residents at the Lough Community Centre in January. Issues regarding the matter arose, including the need for residents to keep their back gardens clean.

One of the meeting outcomes was a commitment from Housing to carry out CCTV survey of the drains of the affected City Council properties in Deermount which is currently taking place. A further commitment was given to check the internal drainage arrangements of the said properties, to ensure that there aren't any large openings. The latter is on-going and the Housing & Community Directorate remains committed to bringing the matter to a close as soon as possible.

11.7 **FABRIC UPGRADE PROGRAMME**

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 16th March, 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Noonans Road, Dean Street, St. Finbarrs Road, Fort Street be included in the Fabric Upgrade Programme.’

(Proposer: Cllr. S. Martin 17/035)

The report stated that Noonan Road, Dean Street, St. Finbarrs Road and Fort Street have been included in Phase One of the Fabric Upgrade Program. In Phase One, occupied social housing, with cavities in their walls and attics, had insulation materials installed to reduce heat loss. Phase One of the Fabric Upgrade Program will be completed throughout the entire City Council housing stock by the end of June 2017.

The Council owned properties on these streets will also be included in Phase Two of the Fabric Upgrade Program. The measures to be included here are window/door upgrades, external wall insulation and dry lining of internal walls where appropriate. The Council is awaiting the announcement of the funding allocation for 2017.

In addition to the above, Cork City Council will commence a pilot project this year with regard to the deep retrofitting of apartment blocks. This project is part of the EU funded “priority 4” suite of projects. If successful, the deep retrofit measures will be extended to all applicable Cork City Council owned apartments. The Council is awaiting the announcement of the funding allocation from the Department of Housing, Planning, Community & Local Government. If the pilot is successful, it is planned to complete a deep retrofit of all apartments before the end of 2020. The term deep retrofit refers to measures to improve the energy efficiency of the property only.

11.8 **NAMING OF HOUSING DEVELOPMENTS**

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 16th March, 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council will ensure that names chosen for its new housing developments will be of local relevance.’

(Proposer: Cllr. T. O’Driscoll 17/040)

The report stated that the City Council will endeavour to ensure that names chosen for new social housing developments are of local relevance. However, the Council, as opportunities arise, may purchase new developments which are under construction and the scheme names may already be in place.

12. **ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE – 20th MARCH 2017**

An Chomhairle considered and noted the minutes of the Roads & Transportation Functional Committee from its meeting held 20th March 2017.

12.1 **ROADWORKS PROGRAMME**

An Chomhairle considered and approved the Director of Services report, dated 16th March 2017 on the progress of the ongoing Roadwork’s Programme for the month ending February 2017.

12.2 **RESURFACE BALLYHOOLEY ROAD**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That the Ballyhooley Road be resurfaced from Keating’s Furniture right up to junction at O’Callaghan’s T.O.P garage. This stretch of road has fallen into a serious state of disrepair and needs urgent attention.’

(Proposer: Cllr. J. Kavanagh 17/022)

The report stated that work on the Cork Cycle Network Phase 2 – Ballyvolane to Centre is anticipated to start in the autumn 2017. In the interim, remedial patching works will be carried out in the coming weeks.

12.3 **TRAFFIC SURVEY IN COOLGARTEN PARK, MAGAZINE ROAD**

An Chomhairle considered and approved the Director of Services Report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That City Council would carry out a traffic survey in Coolgarten Park on Magazine Road with the intention of putting traffic calming measures in place. And also examine exits onto both Glasheen Rd and Magazine Rd. as these are blind spots for residents who are requesting that bollards be put in place to prevent cars parking too near the corners.’

(Proposer: Cllr. H. Cremin 17/041)

The report stated that Coolgarten Park is situated between Glasheen Road and Magazine Road. Parking is permitted in a number of parking bays within Coolgarten Park. At the intersections of Coolgarten Park with Glasheen Rd and Magazine Rd double yellow lines are in place to indicate that this space is not for parking. Whilst short term loading/unloading is permitted on double yellow lines, any other parking is illegal. The Traffic Warden Service will therefore be requested to pay additional attention to Coolgarten Park to deter any illegal parking incidents.

Coolgarten Park is on the list of requests for traffic calming.

12.4 **TRAFFIC ENTERING PARKLEY COURT, MODEL FARM ROAD**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That City Council would put measures in place at Parkley Court Model Farm Rd. to prevent vehicular traffic entering this estate at this pedestrian entrance. Presently there is one steel bollard on the footpath but vehicles are driving onto the grass margin to avoid this.’

(Proposer: Cllr. H. Cremin 17/042)

The report stated that Parkley Court Model Farm Rd. will be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that could be provided there. If deemed appropriate, the measures will be put forward for consideration to be included in the Roads Programme and will be undertaken, subject to funding being available.

12.5 **DOUBLE YELLOW LINES OUTSIDE NO'S 1 TO 13 LOTABEG ESTATE**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council put double yellow lines on the northern side of the roadway outside Nos 1 to 13 Lotabeg Estate as the residents of the area people from outside the area are leaving parked cars all day thus impeding local traffic.’

(Proposer: Cllr. T. Brosnan 17/048)

The report stated that the northern side of the roadway outside Nos 1 to 13 Lotabeg Estate will be assessed for appropriateness of double yellow lines. If deemed appropriate, confirmation of agreement by all residents affected by the installation, will be sought by Cork City Council before the measures can be put forward for inclusion in the Roads Programme.

12.6 **PUBLIC LIGHTING IN TIVOLI ESTATE**

An Chomhairle considered and approved the Director of Services report, dated 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council having taken in charge the new housing estate at the northern side of Tivoli Estate would liaise with the Electricity Supply Board to ensure the public lighting in the area is made to work in the interests of the safety and security of residents.’

(Proposer: Cllr. T. Brosnan 17/049)

The report stated that City Council’s specialist lighting maintenance contractor has completed the Taking-in-Charge inspection for this location and any necessary repairs were put in order. An application for a re-connection of the original supply has been submitted to ESB Networks.

The Transportation Division listed the location as a priority but the works programme is determined solely by ESB Networks.

12.7 **RAMP AT MAGERTON CLOSE**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council would assess re putting in a ramp at/near 18-20 Mangerton Close the Glen, from the road to the footpath as the current access is very far away and residents who are ill or disabled are finding it increasingly difficult to access the road.’

(Proposer: Cllr. J. Sheehan 17/050)

The report stated that this location will be investigated regarding the feasibility of improving access for disabled persons.

12.8 **ROAD SAFETY AT ARDROSTIG CROSS**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council would undertake a review of the safety of the road and speed of traffic a Ardrostig Cross (junction of Bandon Road, Bishopstown Road and Waterfall Road) where a number of accidents have occurred and where the boundary walls of properties have been demolished and that Cork City Council would ensure that the large site at the junction of Bishopstown Road and Hawkes Road is properly secured and screened off with appropriate hoarding that enhances and public realm.’

(Proposer: Cllr. J. Buttimer 17/051)

The report stated that Ardrostig Cross (junction of Bandon Road, Bishopstown Road and Waterfall Road) will be assessed to determine the extent of the problems that exist and identify any possible mitigation measures that could be provided there. Any works deemed appropriate will be inputted into the roads programme and undertaken as soon as resources are available.

12.9 **SURFACE WATER POOLING AND LODGING ON THE N40**

An Chomhairle considered and approved the Director of Services report, dated 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council would present a report on the reasons for significant surface water pooling and lodging on the N40 particularly the section of road between and including the two flyovers at Sarsfield Road and Bandon Road and what remedial measures can and will be taken to reduce and eliminate this serious hazard.’

(Proposer: Cllr. J. Buttimer 17/052)

The report stated that this motion has been deferred.

12.10 **HARBOUR VIEW ROAD REGENERATION PROJECT**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘Given the high volume of traffic through Harbour View Road under The Regeneration Project, Hollyhill Industrial Estate and numerous successful developments in the area that Cork City Council:-

1. Paint the roundabout outside Terence MacSwiney Community College.
2. Repair and paint the traffic calming island at the top of Hollyhill Lane.
3. Repair the potholes along the route.
4. Include Harbour View Road in the Resurfacing programme.’

(Proposer: Cllr. T. Fitzgerald 17/065)

The report stated that the roundabout outside Terence MacSwiney Community College and the traffic calming island at the top of Hollyhill will be assessed to determine the extent of

painting works required. Any works deemed appropriate will be inputted into the road painting programme and undertaken as soon as is practical.

Harbour View Road is not included in the 2017 resurfacing programme but will be considered for future resurfacing programmes. The area and the traffic island at the top of Hollyhill Lane will however be inspected and any essential remedial repairs will be carried out in the coming months.

12.11 **BLACK ASH PARK AND RIDE TO FACILITATE MOTORISTS TRAVELLING TO PÁIRC UÍ CAOIMH**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That the Council carries out a feasibility study into using the Black Ash Park and Ride to facilitate motorists travelling to major events at Páirc Uí Caoimh in advance of it opening later this year.’

(Proposer: Cllr. T. O’Driscoll 17/067)

The report stated that a condition of the grant of planning for Páirc Uí Chaoimh is that specific traffic plans be prepared for varying modes of travel for the varying size events that will be held in the stadium.

The management of Páirc Uí Chaoimh will be required to prepare traffic plans for events into the future. The Council has historically accommodated requests from sporting organisations across the city with regard to the use of the Park and Ride facility in association with events and this will continue into the future.

12.12 **PATHWAY CONNECTING SILVERSPRINGS LAWN AND ASHMOUNT ESTATE, MAYFIELD**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That City Council proceed with the creation of a pathway connecting Silversprings Lawn and Ashmount Estate in Mayfield according to the original planning decision and design (Town Planning Reference 23842/99).

The fence currently blocking this access was originally built to cordon off the construction of residential housing in the early 2000’s, and was supposed to be replaced by a footpath and wall as per TP 23842/99. This pathway was intended to provide freedom of movement for residents between Silversprings and Ashmount.

However, the construction of this pathway was never undertaken, and the fence has since remained in place. Although an opening through the fence has existed since 2002, this has now been closed as of January 2015.

Residents of Silversprings and Ashmount estates in Mayfield are currently separated by this closed fence, which is imposing great inconvenience to those living nearby, and is in direct contradiction to the original planning designs for the area.

The construction of the mandated pathway was never undertaken, and the fence has since remained in place. The closure of this fence has greatly inconvenience the local community. This restriction of free movement for the residents of both Silversprings and Ashmount has affected them in the following ways:

- Young children have been walking on a wall running over and adjacent to the fence, and there exists a serious danger of injury should a child fall on the palisade railings of the fence
- Access to the local GAA and soccer pitches in Ashmount, Boherbuoy and Lotamore has been curtailed
- Users of the 208 bus stop at Ashmount face a lengthened journey, posing a special difficulty to elderly shoppers
- The fencing presents a physical separation for the residents and children of the Silversprings and Ashmount estates who wish to visit friends and relatives in nearby areas
- The fence poses a barrier to walkers, and those residents who seek to enjoy the local amenities
- Children of the Silversprings area are denied access to the green area of Ashmount for recreation.'

(Proposer: Cllr. T. Tynan 17/068)

The report stated that this motion has been referred to the Environment & Recreation Directorate.

12.13 **FILTER LIGHT FROM CLASHDUV ROAD ONTO TOGHER ROAD**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

'I've made numerous representations starting back in 2014 (Filter light turning right from Clashduv Road onto Togher Road reference number – 20488 & 20409) to get a filter light turning right from Clashduv Road onto Togher Road. Everyone is complaining about the lack of a filter light turning right & the delays this has on traffic on the Clashduv side. There is a big fear that people will take risks at this junction and cause accidents due to the lack of time to turn at this junction. This wasn't possible due to the cost but in April 2015 there was an 8 second delay put on the lights after the Vicar's Road side shuts down, allowing the traffic turning right. This had a massive positive affect at reducing the traffic flow for everyone but for some reason this is no longer in place causing the same issues again. Would it be possible to introduce this 8 second delay again please?'

(Proposer: Cllr. T. Moloney 17/073)

The report stated that the Transportation Division will review the timings and signal delay as sought above.

12.14 **PEDESTIRAN CROSSING ON AVENUE DE RENNES, MAHON**

An Chomhairle considered and approved the Director of Services report, dated the 16th March 2017 on the following motion referred to the Committee by An Chomhairle:-

‘That Cork City Council provide an official pedestrian crossing at the already installed ramp on avenue de Rennes, near to Scoil Na Croise Naofa, Mahon.’

(Proposer: Cllr. N. O’Keeffe 17/077)

The report stated that the installed ramp on Avenue de Rennes, near to Scoil Na Croise Naofa, Mahon is an official uncontrolled pedestrian crossing. It can be examined, however, to assess whether any further specific signing and lining works are required. Any works deemed appropriate will be inputted into the road painting programme and undertaken as soon as is practical.
