2. **MINUTES**

Minutes of Ordinary Meeting of An Chomhairle held on 13th May, 2002 were considered and approved with the following amendment :-

An Chomhairle approved the recommendation of Comhairleoir M. Ahern that a member of the Arts Committee would be nominated to the Board of 'Cork Cultural Capital Ltd.' bringing membership to a total of 10 representatives

3. **QUESTION TIME**

3.1 **DERELICT SITE ADJACENT TO 94 WOLFE TONE STREET**

In response to question submitted by Comhairleoir D. Wallace, a written reply was circulated which stated that this site is not on the derelict sites register. However, the owner of this property has applied for and obtained planning permission for this site. Negotiations will be opened with the owner with a view to progressing redevelopment of this site. If the development does not commence within 4 months, this property will be placed on the Derelict Sites Register and a derelict sites levy will be imposed accordingly.

3.2 **CALMING MEASURES IN HILLCREST AND BLARNEY ROAD**

In response to question submitted by Seanoir D. McCarthy, a written reply was circulated which stated that the section of Blarney Road between the junction with Shanakiel Road and the school on Blarney Road, has been selected for traffic calming works in this year's roads programme.

Volume and speed traffic surveys have been carried out and the design of appropriate traffic calming measures is being undertaken. When the design work is completed in the next few weeks, the necessary consultation process under the Road Traffic Acts will begin. This process includes official notices in the newspaper and consultation with the Gardaí.

Actual work on the ground will begin as soon as possible after the successful completion of the consultation process. The work earmarked to be done in Hillcrest has to go through the same process and will be done at the same time as the work on Blarney Road.

3.3 **NOS. 12, 13 AND 18 BALLINDERRY PARK**

In response to question submitted by Comhairleoir T. Brosnan, a written reply was circulated which stated as follows :

***Would the Manager please explain why Nos. 12, 13 and 18 Ballinderry Park continue to remain boarded up and when can residents expect them to be let out.***

The position with regard to the vacant house at 12 Ballinderry Park is as follows. This property appears to have been abandoned by the tenants in later March of this year and suffered fire damage. The property was shuttered for security reasons pending clarification of the circumstances surrounding the abandonment. The legal position with regard to this dwelling has to be regularised by Court process which is now being initiated. Repairs can then be undertaken.

In relation to properties at 13 and 18 Ballinderry Park, repair work to both these properties is essentially completed with the exception of painting work. This work has been scheduled to be carried out within the next 2 weeks after which time the dwellings will be available for letting.

***In addition, when it comes to letting out would the Manager please ensure that potential tenants are vetted to ensure that there is no history of unruly/unsociable behaviour in any previous letting?***

Cork City Council allocate tenancies in accordance with the Scheme of Letting Priorities, as adopted by Council, and the provisions of the Housing Act, 1997. It is Cork City Council's policy to ensure that all potential tenants are vetted to ensure there is no history of anti-social behaviour. A letting may be declined in the event of Anti-Social Behaviour.

In relation to transfers from one property to another the previous tenancy background is checked before an allocation is made.

#### 3.4 **USE OF CORK CITY COUNCIL'S COAT OF ARMS, CREST OR LOGO**

In response to question submitted by Comhairleoir B. Bermingham, a written reply was circulated which stated that Cork City Council has no objection to members of Council using the Cork Coat of Arms on correspondence and promotional/information documents provided such documents relate to that individual's functions as a member of Cork City Council.

#### 3.5 **MARDYKE WALK**

In response to question submitted by Comhairleoir C. Burke, a written reply was circulated which stated that inbound traffic was diverted along Mardyke Walk to allow Main Drainage works to take place on Western Road. Prior to the works at a public meeting it was explained that this diversion was a temporary one and that traffic arrangements would revert to normal when the works on Western Road are completed. The works are progressing well and are ahead of schedule. It is anticipated that works will be completed in August or early

September, at which stage the barrier will be replaced at the western end of Mardyke Walk.

In consultation with the Gardai and the residents, considerable effort has gone into sign posting, traffic calming measures and the introduction of three signal controlled pedestrian crossings. A restriction has also been introduced to prevent vehicles over 5 tonnes, except for buses, using the road. The Gardai, who are the relevant traffic authority, are satisfied that the road is suitable for traffic and that adequate safety measures have been introduced. The operation of this temporary diversion, including safety aspects, are discussed at a weekly meeting between the Gardai and the City Council. Prior to the introduction of the traffic diversion, the Parks Section carried out any necessary pruning and protection of the existing trees on the Mardyke and Ferry Walk. They carry out routine supervision of all the Main Drainage contracts to minimise interference with existing trees. They were present during the works on Ferry Walk and ensured that the root system of the existing trees were not interfered with. The Senior Executive Parks Superintendent, Liam Casey, is available to meet residents if they so wish. The preservation of the Mardyke as an amenity area for recreational use by all age groups is a key policy in the City's Environmental Strategy as set out in the City Development Plan Review 1998, as is the connection of the Mardyke to the City Centre. A scheme for the enhancement of the Mardyke has been submitted to the Department of the Environment and Local Government as part of the City's Regeneration application for 2000-2006.

### 3.6 **STANDING ORDERS**

In response to question submitted by Comhairleoir J. Kelleher, a written reply was circulated which stated that the Corporate Affairs Directorate and the City Council's Law Department are currently reviewing the City Council's Standing Orders in accordance with our obligations under parts 6 and 7 of the Local Government Act, 2001 with a view to updating those presently in use. A draft of the new Standing Orders will be circulated to Council in early June for consideration. The views of Council will be taken on board and any amendments necessary will be made to the document. The final draft will be presented to Council for adoption at its meeting on June 24<sup>th</sup>.
