

Application for Free Electric Vehicle Parking Annual Ticket at Black Ash Park and Ride 2015

I, _____ (*print name*) (hereinafter called 'the applicant') hereby apply to Cork City Council to procure an Annual Ticket in respect of free parking and bus fare at the Black Ash Park and Ride Facility (hereinafter called 'the Facility') for the electric vehicle bearing identification mark _____

Terms & Conditions

1. Cork City Council shall provide 50 free Electric Vehicle Parking Annual Tickets to eligible applicants at the Black Ash park and ride facility. In the event that a greater number of valid applications are received than the available tickets, the tickets shall be allocated by Cork City Council on a 'first come, first served' basis.
2. The Annual Ticket shall be issued at the absolute discretion of Cork City Council, subject to the provision of acceptable proof of eligibility by the applicant (e.g. vehicle log book). By submitting this application, the applicant accepts that such proof may be subject to independent verification by Cork City Council.
3. Subject to ongoing compliance by the applicant with these Terms and Conditions, and notwithstanding the date of issue of the ticket, the Annual Ticket shall remain valid for use in respect of the Facility until **31st December 2015**.
4. The Annual Ticket shall be issued on the basis of the information supplied by the applicant. Should any information supplied to Cork City Council be found to be false, Cork City Council reserves the right to terminate the Annual Ticket immediately and without notice to the applicant.
5. The Annual Ticket shall be issued to the applicant for the benefit of the electric vehicle specified on this application only and may not be used for any other vehicle. If, during the period of validity of the Annual Ticket, the applicant changes from the vehicle specified to another electric vehicle, this shall be notified in writing to Cork City Council who may, at its discretion, allow the transfer of the Annual Ticket to the new vehicle. Failure to comply with this clause may lead to termination of the Annual Ticket.
6. The Annual Ticket shall be issued for use at the Black Ash Park and Ride Facility only and shall permit the applicant to park the specified vehicle in the designated Electric Vehicle parking area at the Facility and to travel in the Facility Buses to and from Lapp's Quay in the City of Cork without payment. The ticket shall not confer any right to access to or use of a charge point for the period of parking.
7. The Annual Ticket is non-transferable and has no alternative monetary value if the applicant ceases use of the ticket or the ticket is otherwise terminated before the expiration date of 31st December 2015.
8. The applicant shall always park the specified vehicle in the area designated for electric vehicle parking at the Facility. Failure to comply with this clause may lead to termination of the Annual Ticket.
9. The Annual Ticket shall be valid during the hours of operation of the facility for the period of its validity. Any additional charges or penalties incurred by the applicant shall be discharged by the applicant (i.e. Overnight or Late Release Charges) and shall not be covered by the Annual Ticket.
10. Cork City Council, its employees or agents disclaim all liability for any accident, loss, or damage to persons, vehicles, accessories or contents which occurs whilst the applicant is within the Facility, the Facility Buses or any Facility Structures. The applicant and all persons using the Facility, the Facility Buses or any Facility Structures at any time, do so at their own risk in all respects.
11. Should the Annual Ticket be lost or destroyed, it shall be the applicant's responsibility to inform the Facility manager immediately. A fee of €20 will be charged for the issue of any replacement Annual Ticket.
12. Applicants are advised that the completed application together with all submitted documentation in support of the application will be required to be retained by Cork City Council for the purpose of audit inspection by both the Local Government Auditor and the City Council's Internal Auditor for a period of no longer than 2 ½ years.

In consideration of the issue by Cork City Council of an Annual Ticket to me, I hereby accept and agree to be bound by the terms and conditions listed above with regard to the issue of the Annual Ticket for the Facility and my use thereof.
