SuperValu TidyTowns Competition 2021

Entry Process

Entry to the 2021 SuperValu TidyTowns Competition will be by electronic means only

Groups should access the entry form and associated terms and conditions at www.tidytowns.ie. The closing date for the submission of entry forms will be Friday, July 2nd, 2021. Late applications will not be accepted.

Once the group have their entry form completed, they should rename it to their town or village name, e.g. "The Town Entry Form", they should rename their Map and TidyTowns plan likewise. If you wish all three items can be incorporated into one document.

Your entry material should be saved in a folder on your desktop or computer for ease of access when emailing your entry.

Once you have your entry complete you should email it together with any associated material to the TidyTowns unit in the Department of Rural and Community Development. The email to use is tidytowns@drcd.gov.ie

In recent years, some groups encountered difficulties in emailing their entries due to the size of the material they were submitting. We have raised this with the Office of the Government Chief Information Officer and this issue should now be resolved. The limit on the size of material allowable has been increased from 20MB to 30 MB, so that should be more than sufficient. However, if you do encounter any difficuly in emailing your entry, please get in touch with the TidyTowns unit.

We are requesting groups to please visit the TidyTowns website at https://www.tidytowns.ie/competition/registered-entries/ to ensure your entry has been received and registered for the 2021 competition.

If your entry has not been listed by July 14th, please contact the TidyTowns unit at tidytowns@drcd.gov.ie and we will assist you.

Thank you all for your ongoing cooperation, the competition would not be possible without all of you and the efforts you put in all year round in keeping our towns and villages much nicer places in which to live, work and visit.

Dromiskin TidyTowns doing it's bit for Climate Change!!

The County Louth village of Dromiskin is buzzing with excitement following the completion of its most recent LEADER funded project. Despite the recent challenges brought about by the Covid-19 pandemic Dromiskin rose to the challenge of fundraising in excess of €20k through a 'Go Fund Me' page, Corporate Companion Scheme, individual donations, calendar sales and clothing collection schemes.

The TidyTowns committee, in its 30th year, was conscious of the need to increase the tree stock in the village but were severely restricted by the lack of public green space and had to be inventive in terms of delivering on their objective. The committee is exceptionally lucky to have the voluntary input of local resident Kevin Halpenny, a professional Landscape Architect employed as Chief Parks Superintendent with Fingal County Council who recommended and project managed a SuDs tree planting scheme which involved the construction of 4 Integrated Constructed Tree Pits, incorporating Sustainable Drainage Systems (SuDS) located along the public footpath in the village centre. The Tree Pit Construction works included the resurfacing (paving) of the section of public footpath located above the tree pits in question with Castlestone Concrete Paving along approximately 30 metres of 2 metre wide footpath and supply of 4 specimen street trees (Columnar Oaks) using an approved root anchor system, compatible with the Constructed Tree Pit Specifications, which formed

a key element of the overall project.





To their knowledge Dromiskin TidyTowns is the only voluntary group to procure funding for and manage this type of project which was made possible as a result of having Kevin as project manager and using his professional experience of implementing larger scale similar projects in urban areas. The overall cost of the project was €48,000 with a 75% grant received from LEADER under the Rural Development Programme (RDP) and the balance of €12,000 raised through two extremely generous contributions under Dromiskin TidyTowns Corporate Companion Scheme. The completed project has made a huge difference to the visual appeal of the village centre as well contributing to reducing the carbon footprint of the community with climate positive actions and sustainability an integral element of the project.

Shown above is a before and after picture of the project, well done to all involved, it looks fantastic.

National Outdoor Recreation Strategy Public Consultation

Minister Heather Humphreys, T.D. launched a public consultation on 2nd June, seeking the views of stakeholders and the public to inform the Government's new National Outdoor Recreation Strategy.

A key action in Our Rural Future is a new National Outdoor Strategy. Recreation The strategy will provide a vision and an overarching framework for the growth and development of outdoor recreation in Ireland, creating a shared vision for the many strategies, programmes, elements agencies and Ireland's outdoor recreation sector.



Outdoor recreation is going to play a valuable role in supporting Ireland's future recovery as restrictions on movements are relaxed and the tourism sector fully reopens. A cohesive National Outdoor Recreation Strategy has the capacity to benefit our local economies, while also promoting responsible use of the countryside.

So what is included in outdoor recreation? By 'outdoor recreation', we mean activities that take place in the natural environment, such as walking, canoeing, mountain biking, orienteering and wild swimming. It does not include activities that take place outdoors on confined courses or pitches (such as golf, football, show jumping) nor motorised activities (such as quads).

The development of the Strategy is being led by <u>Comhairle na Tuaithe</u> (The Countryside Council) in partnership with the Department and will be delivered as a cross-Government Strategy. Comhairle na Tuaithe is a collaborative body which comprises of representatives from farming organisations, recreational users such as Mountaineering Ireland, Canoeing Ireland and State bodies such as the Coillte and Fáilte Ireland.

This is the first stage of a two-stage consultation process whereby interested stakeholders and individuals are encouraged to share their views on outdoor recreation via an online questionnaire at https://www.gov.ie/en/consultation/42e3a-public-consultation-on-a-national-strategy-on-outdoor-recreation/. The closing date for receipt of submissions is **5pm on 23rd June 2021**. At the second stage of the public consultation later this year, a draft Strategy document will be issued whereby interested stakeholders and individuals will be invited to give detailed feedback before the Strategy is finalised.

Special Awards 2021

Each year in the SuperValu TidyTowns competition, we include a number of special awards. These awards add a different but associated dimension to the competition. We only bring special awards on, if they align to one or more of the competition categories, so no new work is required. If you are entering a special award, make sure and reference it in the relevant category. The following will give you a flavour of some of the awards on offer this year, all with fantastic prizes. In excess of €66,000 is up for grabs in the special awards categories.

To encourage and support groups in entering one or more of these awards, we have extended the closing date just for the special awards. The closing date for each award is given below, some are the same as the main competition, others are some weeks later.

Please do not confuse these with the closing date for the main competition entry form, which is **Friday July 2nd, 2021**.

Covid-19 Community Award – Staying Together while Apart

For this award, we are asking groups to tell the adjudicator what steps they took to keep their community, connected, engaged and most important of all, how they kept focussed and positive. The adjudicator will take these points into consideration for this special award for 2021 and also for the overall mark given to each group in the main competition. All groups who complete the section in the entry form will stand to gain marks in the competition and also be considered for the "Covid-19 Community Award"

Sponsored by the SuperValu, this award has a prize fund of €5,000. Closing date for this award is <u>Friday July 2nd 2021.</u> In line with the closing date of the main competition.

The Islands Award

The Islands Award is awarded to the two highest scoring entrants that is an island not connected to the mainland by a bridge, is cut off daily from the mainland by the tide, is permanently inhabited and is not in private ownership.



This award is sponsored by the Department of Rural and Community Development and has a prize fund of €1,500. The closing date for this award is **Friday July 2**nd **2021.** In line with the closing date of the main competition.

Gaeltacht Award

The Gaeltacht Award is awarded to the two highest scoring entrants from a Gaeltacht area. The Entry Form must be completed in Irish.

Agent Brite Litter Awareness

Recycling-on-the-Go' RotG is a way of providing public-facing recycling facilities to enable people to recycle when they are away from home or work. PEL Waste Reduction Equipment are sponsoring the 'Agent Brite Litter Awareness' Special Award to raise awareness and benefits of RotG to the local community. The purpose of the award is to promote 'Recycling-on-the-Go' and encourage the public to segregate different types of litter when depositing in a bin.

This award is sponsored by PEL Waste Reduction Equipment and has a prize fund worth €7,000 through the rental costs for four units of the PEL120 SolarStreetBin™ in the 'Agent Brite' livery. Workshops in the winning area



will be facilitated to promote the concept of "RotG". The application will be a written submission describing the expected benefits to be accrued from winning the 'Agent Brite Litter Awareness' Special Award.

Now in its second year, the Leave No Trace TidyTowns Special Award recognises communities for their significant efforts to protect and enhance the natural environment and the promotion of responsibility in the outdoors. Through recognising these communities, Leave No Trace Ireland seeks to inspire other communities to take extraordinary actions to protect and promote responsible outdoor recreation. The award is open to any community group who has shown an appreciation for their outdoor environment.

This award is sponsored by Leave No Trace Ireland and has a prize of training to the value of €1,000. The closing date for this award is **Friday July 23**rd **2021.**



EPA Circular Economy Award

The EPA Circular Economy Award is to recognise communities that have undertaken activities that support a circular economy. In a circular economy waste is prevented and products are reused or repaired for reuse. By preventing waste and supporting the circular economy we can make the most of our resources while protecting the environment. Work done under the main competition category 'Sustainability – doing more with less' can be relevant to this special award.



This award is sponsored by the Environmental Protection Agency and has a prize fund of €2,000. The closing date for this award is <u>Friday July 23rd</u> 2021.

Waters and Communities

The Waters and Communities Special Award aims to encourage community groups to get more involved with their local waterbodies





by helping to preserve, promote and fully utilise their local natural water heritage. The award is open to any community group who has shown an appreciation for their water environment and water heritage by showing examples of initiatives undertaken during, and in line with, Covid-19 restrictions.



This award is sponsored by the Sponsored by Inland Fisheries Ireland, Waterways Ireland and the Local Authority Waters Programme and has a prize fund of €7,000. The closing date for this award is **Friday July 23rd 2021.**

Can It! - Every Can Counts

Every Can Counts inspires and empowers people to recycle their drink cans and make a real difference. We're aiming for 100% can recycling, and we want TidyTowns groups to join us and help make it happen. The 'Can It!' award challenges groups to increase the drink can recycling points throughout their town. Entrants will be judged on the number of can recycling points and the variety of locations in relation to population. Help spread the message of drink can recycling and tag us in your efforts on social media and your group could win a can crusher.



This award is sponsored by Every Can Counts and has a prize fund of €1,500 and a can crusher. The closing date for this award is **Friday July 23rd 2021.**

Tree Project

The Tree Project Award recognises the huge impact that properly positioned trees can have in a town or village and the importance of having the right tree in the right place. It is essential that careful thought is put into not only the planting but also the management of the trees over their life-span. The award rewards the TidyTowns Committee which has demonstrated the highest tree placement and maintenance standards.



This award is sponsored by the Tree Council of Ireland and has a prize fund of €1,000. The closing date for this award is **Friday July 23**rd **2021.**

Climate Action & Air Quality

The overall aim of the Climate Action and Air Quality Award, sponsored by the Department of Environment, Climate and Communications is to recognise the great input local communities can make in addressing climate change and air quality. The purpose of this award is to raise awareness and promote behaviour change.

Sustainable Development Goals

The purpose of this award is to promote the national awareness of the 17 Sustainable Development Goals, (SDGs) by recognising the great input local communities can play in helping Ireland play its part in fully achieving the SDGs by 2030. The purpose of this award is to raise awareness and promote behavioural change at a local and community level.

This award has a prize fund of €5,000 and also closes on Friday July 23rd 2021.

Young Persons in TidyTowns

The Young Persons Award is aimed at the 16 to 24 age group who are actively involved in projects and initiatives of their local TidyTowns group throughout the year. It is not open to schools to apply. Entries should be submitted using the Young Persons Award entry form. Photographs can be used to support your entry.

Entries under the Young Persons Award should demonstrate how TidyTowns groups actively involve young people in the 16 to 24 age group in contributing on an ongoing basis to their local TidyTowns activities, including through their membership of, or direct engagement with, the Groups. Initiatives undertaken by the group to encourage greater involvement from this age group should also be included.

The award will be presented to the TidyTowns Group whose initiatives have resulted in an increase in involvement from the 16 to 24 age group, resulting in a positive outcome for the TidyTowns group and wider community and demonstrating how young people can have an active leadership role within their community.

The Town Challenge Award

The Royal Institute of the Architects of Ireland (RIAI) is providing the services of a Registered Architect to work with a local TidyTowns Committee to create a visionary urban design solution to a problem in your town. The award consists of an architectural commission.



If your town or village has difficulties, for example with derelict sites, signage, lack of public space, traffic or parking issues, this RIAI Award will give you the opportunity to work with a Registered Architect to develop an urban design solution that can solve a problem and enhance your town or village. Registered Architects are trained to develop and deliver solutions for our built environment.

In order to apply, the local TidyTowns committee will write a short paragraph which identifies the positive characteristics of the town, as well as its problems (see application form). This should be supported with photographs.

This award is sponsored by the Royal Institute of the Architects of Ireland and has a prize worth €5,000 consisting of a commissioned Architect design solution that can solve a problem and enhance your town or village. The closing date for this award is **Friday July 23rd 2021.**

Shopfront Award

The RIAI Shopfront Award is a Special Award, designed to raise awareness and promote good shopfronts in Irish towns and villages. The RIAI Shopfront Collaboration Award aims to support a TidyTowns Committee who wish to provide guidelines for the design of shopfronts in an historic context with the help of a Registered Architect. Well-kept historic shopfronts and well-designed modern shopfronts are equally valid.

This award is also sponsored by the Royal Institute of the Architects of Ireland and has a prize worth €2,000 consisting of an architectural commission which will be made publicly available, and a presentation given to the local TidyTowns Committee. The closing date for this award is **Friday July 23rd 2021.**

Good Windows Award

The third award sponsored by the RIAI is the Good Windows Award is a Special Award to promote appropriate windows in Irish towns and villages. The streets of Irish towns and villages are composed of both historic and modern buildings. Well-kept historic windows and well-designed modern windows are equally valid.

In order to apply, the local TidyTowns committee will complete the entry form and submit photographs of two buildings which are located in a street and have appropriate windows. The photographs should clearly show the building and the windows and include an example of a well-kept historic window in an urban street and an example of a good modern window or fully glazed opening in an urban street.



This award is also sponsored by the Royal Institute of the Architects of Ireland and has a prize worth €500. The closing date for this award is **Friday July 23rd 2021.**

Pollinator Award

The Local Authority
Pollinator Award aims to
encourage TidyTowns
groups to implement
pollinator-friendly actions in



their towns and villages as part of the TidyTowns competition. Wild Irish bees, crucial to the pollination of our plants, trees and vegetables, are in decline - this is because we've drastically reduced the areas where they can nest and the amount of food our countryside provides for them. The aim of the award is to reverse this trend by encouraging TidyTowns groups to take simple pollinator-friendly measures in their local area. The Local Authority Pollinator Award supports the All-Ireland Pollinator Plan and is sponsored by the Heritage Offices & Biodiversity Offices of Local Authorities across Ireland.



This award is sponsored by Heritage Offices & Biodiversity Offices of Local Authorities across Ireland, in partnership with the National Biodiversity Data Centre and has a prize worth €10,000. The closing date for this award is **Friday July 23rd 2021.**

Gum Litter Taskforce



Sneem TidyTowns Lockdown Activities

Gardening has been a successful lockdown activity and we in Sneem are very fortunate to have a Community Polytunnel and Allotments located in the Garden of the Senses in the heart of our village.



We have 10 outdoor beds in our allotment and 20 indoor raised beds in the polytunnel and this year we welcomed international some new gardeners who work in the hotels and found local themselves with time on their hands while the hotels were closed. One of them (from Macedonia) has proven very handy around the Garden of the Senses upcycling old items and creating clever solutions to make life easier for our diverse group.

An old table that had been created from pallets was taking up too much space in the polytunnel, so our Macedonian handyman has repurposed it into a new potting bench with storage underneath and several small stacking stools which can be used to sit on for that very important cup of tea. We were initially wondering why he made the stools so low but have since discovered that they are the perfect height for sitting on to weed your bed!





He built a new bench from a leftover plank outside the polytunnel which means that elderly gardeners can sit down while the watering can fills. We used to have to bend down and hold the can in place.

A pine bedframe was being thrown out and was offered to the group. It has been repurposed into a fabulous new throne-like bench for the community allotments. Someone donated a can of preservative so this fabulous bench cost nothing!





The gate into the allotments was falling apart so we used some of our TidyTowns funding to purchase some wood and hardware locally and again, our handyman fashioned a beautiful gate and posts which fit seamlessly with the willow hedging surrounding the allotments.

The closing date for entries to this year's competition is August 15th and the competition will culminate in a prize giving ceremony in the Autumn. Net Zero Carbon - What is it?

The effects of climate change are beginning to show around the world: glaciers have shrunk, plant and animal ranges have shifted and trees are flowering sooner, there has been a loss of sea ice and accelerated sea level rise and we are now experiencing more intense climate events. Many governments have declared a climate emergency, realising that the problem is man-made and that only the human population can rectify the situation. To do this, research tells is that global greenhouse gas (GHG) i emissions will need to drop by half by 2030 and reach net zero carbon by 2050.



The 'net zero carbon' target seeks to achieve net-zero emissions when any remaining human-**GHG** caused emissions are balanced out by **GHGs** removing

from the atmosphere in a process known as carbon removal. Basically, we need to ensure that we take out of the atmosphere the same amount of carbon that we put in so that the balance is zero or 'net zero'.

To understand net carbon zero, we should have a basic understanding of carbon accounting. Consider carbon to be a bit like money. Most of the time we have a rough estimate of how much things cost without looking at the price tag. We may not have the exact cost, but we know a bottle of wine is more expensive than a cup of tea and a lot cheaper than paying the mortgage. However unlike with money, we are not used to thinking about the cost of carbon, therefore it is much harder to tell how much we are spending because we can't see it nor is it documented. Furthermore, we can't personally nor tangibly experience the consequences of our individual carbon impact, as its spread across the world impacting on us all.

Legislation

The Climate Action and Low Carbon Development (Amendment) Bill 2021 is currently going through Dáil Éireann, it's at the third stage.



The Bill draws on recommendations from the cross section of Irish people who took part in the Citizens Assembly on Climate, as well as those of a Joint Oireachtas committee on Climate Action. It is also a cornerstone of the Programme for Government and was identified as a priority for legislation.

New 2050 Target

The Bill will put into Irish law a commitment for net-zero greenhouse gas emissions by 2050, through a 'National 2050 Climate Objective'— that the State will pursue the transition to a climate resilient and climate neutral economy by the end of the year 2050. A climate neutral economy means a sustainable economy where greenhouse gas emissions are balanced or exceeded by their removal.

What does it mean for us as citizens?

We will change how we heat our homes, generate power, travel, grow our food and run our businesses. Positive actions from the Bill should result in cleaner air, warmer and easier to run homes, shorter commutes, and greater energy security. It also creates opportunities for Ireland to use the resources we have and those we generate in a more circular sustainable way. This will lead to the creation of new jobs and the requirement of different skill sets to respond, for example, repairing and retrofitting. We can expect to pay more tax for our cars that are powered by pollutants such as diesel and petrol, as well as be expected to recycle more and waste less, particularly food. The imposition of punitive measures such as fines and taxes could happen, but there will also be incentives to change behaviours, such as grants.

What can we do?

Given the impact the bill will have on Irish society and the economy over the next 30 years, it is imperative that we get ahead of the game. We can start to educate and create awareness of the changes afoot.

- Firstly, do you understand your carbon footprint or the carbon footprint for your household? Gaining a sense of where your carbon impacts come from is important. There are many simple carbon footprint calculators freely available online, for example, https://www.carbonfootprint.com/calculator.aspx or https://footprint.wwf.org.uk/#/
- Given that it is mooted that the government will, at some stage, likely phase out
 the use of fossil fuel cars, we can lobby ESB to install new and/or additional Evehicle chargers in our towns and villages.
- We can check to see if our community buildings/houses are on renewable energy tariff.
- We can continue to raise awareness on food waste. https://stopfoodwaste.ie/
- Some homeowners may opt to generate their own electricity and sell back to the grid under a scheme for micro-generation while other communities are getting more involved in the SEAI's Sustainable Energy Communities Scheme. https://www.seai.ie/community-energy/sustainable-energy-communities/
- Land use offers significant potential to act as a sink for carbon. We could consider additional planting of trees for carbon sequestration. But remember right trees in the right places.

- We can raise awareness in relation to Building Energy rating (BER) and provide information on building retrofitting.
- We can promote the use of public transport, if available. Lobby for better timetabling or increased routes if public transport is lacking in your area. The setting up of Park n Stride or Park n Ride initiatives and the provision of cycling infrastructure can all have a positive impact on the carbon impact of our journeys and commutes.
- Keep talking! Having conversations about climate change in our daily lives plays
 a huge role in creating social change. We take our cues about what's important
 from what we hear our family, friends, colleagues and neighbours talking about.
 But talking about climate change, is hard. If you are interested, check out the

TidyTowns Survey

We recently asked you all to participate in a survey so that we can capture some statistics on the great work that TidyTowns groups and their volunteers do each year the length and breadth of the country.

From the responses received so far, we can say that groups around the country give over 3 million hours of their time to TidyTowns activities, close to 30,000 trees have been planted since January 2019 with close to 15,000 flower beds being maintained 96% of groups are linked to other organisation, 88% to on an ongoing basis. Over a local school, 64% to the local GAA Club, 43% to a local secondary school, 34% to your local church, that is some serious networking and collaboration.

The results to date also show that over 21,000 tonnes of litter are collected each year by TidyTowns volunteers.
