- 5. A <u>photocopy</u> of your <u>Current vehicle insurance certificate</u> this documentation must match the applicant's name and address. <u>Please note insurance discs or insurance schedules/Cover Letters from Insurance Companies are not acceptable.</u>
- 6. Fee of €10.00 applies to a Change of Vehicle. The new Permit will be valid until the expiry date of your existing permit.
- Please send the Postal Application to Cork City Council, Parking Division, Room 335, City Hall, Cork, T12
 T997 payable by Cheque, Bank Draft or Postal Order made payable to <u>Cork City Council</u>.

- 8. The Renewal of a permit is the responsibility of the Permit Holder.
- 9. Please allow 5 10 working days for the processing of your application.
- 10. Applicants are advised that the completed application from together with all submitted documentation in support of the application will be required to be retained by Cork City Council for the purpose of audit inspection by both the Local Government Auditor and the City Council's Internal Auditor for a period of no longer than 2 ½ years.
