We ask that Cork City Council puts a team in place to look at this as a viable option and put out tenders for building firms to do the building works directly for the Council with the company allowed an agreed maximum profit margin of 10-12pc. It would effectively be taking on a construction company as a state building entity, would significantly reduce the cost of housing for the Council and reap rewards for the company also. Can Cork City Council investigate the viability of this and perhaps start a pilot?'

12.2.5 CULTURALLY APPROPRIATE HOUSING FOR TRAVELLERS

'That Cork City Council, accepting the findings of the report of the Cork and Kerry Regional Traveller Accommodation Working Group, Traveller Homelessness: A Hidden Crisis advising that Traveller children are 12 times more likely to be homeless resolves to address this issue immediately.

To provide Travellers with culturally appropriate housing in line with international human rights obligations Cork City Council will explore borrowing an appropriate amount of money. This borrowing is pursuant to section 25 of the Traveller Accommodation Act 1998:

25.—(1) Subject to subsection (2), a housing authority may make a loan for the—

(a) acquisition or repair of a caravan within the meaning of section 13 of the Act of 1988 (as amended by section 29), or

(b) acquisition of land for the purpose of providing a site and any construction works required for such purpose.

(2) The Minister shall, with the consent of the Minister for Finance, specify terms and conditions for loans made under subsection (1)

(3) Subsections (2) to (14) of section 11 of the Act of 1992 shall apply, to such extent as may be appropriate and with any necessary modifications, to a loan made under this section.

Cork City Council would consider that under the provided definition of "caravan" that this funding can be used for modular housing or other forms of Traveller specific accommodation with the agreement of the Traveller community.

(6) In this section "caravan" means any structure designed or adapted for human habitation which is capable of being moved from one place to another, whether by towing

or transport on a vehicle or trailer, and includes a motor vehicle so designed or adapted and a mobile home, but does not include a tent.'

26.1 **LEGISLATION ON COLOUR BLINDNESS**

'I propose that this Council recognises the fact that thousands of people resident in the State are colour blind, and that there are many workers who wish to train and study for a wide range of trades and professions. However, they are then denied access to these areas of work due to the current health and safety legislation.

In the UK and Northern Ireland, spectacles are legally available which allow people with colour blindness to successfully train and work in their career of choice.

I urge this Council to call on the Ministers for Health and Labour to introduce legislation to allow these people to pursue their chosen profession.'

26.2 HOUSING NEEDS OF CHILDREN WITH AUTISM

'At this time, thousands of families are on the City Council housing waiting list. Amongst these families, there are well over one thousand children with autism.

Many of these children have reports from qualified professionals in this field who recommend to the housing authority at City Hall that the needs of these children are met regarding residential space and safety.

I urge this Council to call on the Minister for Housing to recognise the plight of these children and to act with urgency to provide the necessary staff and funding to Cork City Council so that the needs of these children are met.'

(Proposer: Cllr. T. Tynan 23/194)

26.3 **<u>REMOVE SALE OR REFURBISHMENT AS REASONS TO END A TENANCY</u>**

'That Cork City Council supports removing sale or refurbishment as reasons to end a tenancy, where there is a risk of homelessness, and will write to the Minister for Housing, Local Government and Heritage requesting he immediately progresses legislation to this effect.'

(Proposer: Cllr. O. Moran 23/195)

26.4 **DELAYS BY AN BORD PLEANÁLA**

'That Cork City Council is very concerned that delays in An Bord Pleanála are affecting the delivery of infrastructure projects; including timely decisions on compulsory purchase orders and risks to projects such as the Cork Area Commuter Rail programme in meeting deadlines for European and other funding opportunities; and will write to the Minister for Housing, Local Government and Heritage and the Minister for Transport on the matter.'

26.5 CONSULTATIVE FORUM ON INTERNATIONAL SECURITY POLICY

'Cork City Council shall write to the Minister of Foreign Affairs to indicate that it will not cooperate with the Consultative Forum on International Security Policy. The forum is a thinly-veiled exercise to legitimate an erosion of the State's constitutional neutrality in international affairs and is a wholly inappropriate and inadequate means by which to address a possible change in State policy on a core constitutional provision.'

(Proposer: Cllr. L. Bogue 23/212)

26.6 FINANCIAL SUPPORT FOR TRACKER MORTGAGES

'That Cork City Council call on the Government to introduce financial support for those who are struggling with tracker mortgages due to the significant increase of 20% since July 2022 across the nation.

The current situation has left many families in financial hardship, and it is time for the Government to step in and provide the necessary assistance to alleviate the burden of this ever-increasing mortgage cost. We call upon the Government to take swift action and introduce policies that will provide a safety net for those affected.

And recognize that there is no one-size-fits-all solution to such a complex issue, and financial assistance alone may not be enough, given the fluctuating economic climate.

However, a combination of financial aid and the introduction of long-term policies will help ease the burden for those affected.'

26.7 HOUSING FOR INTERNATIONAL PROTECTION APPLICANTS

'That Cork City Council write to the Minister for Integration and the Minister for Public Works and ask them both to meet with all Councillors with Department officials to outline the programme of works for any further housing developments for international protection applicants and refugees fleeing the despicable war on Ukraine.

It's important to point out that I am in favour of housing refugees, but it would help if Councils were consulted to help us answer questions to the public and stop the spread of false news and rumour.'
