Town and village centres will then be considered for implementation of the guidance.'

28.2 NEGATIVE REPORTING OF LITTERING IN CORK CITY

At present we are pushing ahead with the installation of a Greenway along the old line and I'm at a loss as to why we cannot reinstall the rail line in conjunction with the Greenway as it would make perfect sense to do this now in the interest of Climate Change while at the same time promoting the use of public transport.'

- Resourcing a designated staff member (midwife) for early miscarriage care to enable development of individualised care plans after a woman's first miscarriage in each of the 19 maternity hospitals/units.
- Access to dedicated counselling and psychological supports after a person's first and subsequent miscarriages.
- A focus on second trimester pregnancy loss, to include improved and standardised investigation, management, care and supports, with enhanced care in a subsequent pregnancy, across all 19 maternity hospitals/units.
- Providing necessary resources and supports for healthcare staff, teams and hospitals to access and learn from continuing professional development and training opportunities around bereavement care.
- Enhanced funding to ensure that there are dedicated spaces within maternity units/hospitals for the delivery of high quality bereavement care that facilitates privacy and dignity.
- Standardised reporting of first and second trimester miscarriage rates nationally to inform service delivery and improvements.'
