VOTE ON WHETHER OR NOT TO ADJUST THE BASIC RATE OF LPT

On the proposal of An tArd-Mhéara, seconded by Comhairleoir S. Martin a vote was called for to **not** adjust the basic rate of LPT, where there appeared as follows: -

As the numbers voting in favour of **not** adjusting the LPT rate exceeded those voting against, An tArd-Mhéara declared the vote to **not** adjust the LPT rate carried.

The following Resolution was then proposed by Comhairleoir S. Martin and seconded by Comhairleoir J. Buttimer: -

“It is resolved that at the meeting of Cork City Council on 28th September 2017, the basic rate of the Local Property Tax should stand unchanged for the year 2018 in respect of the relevant residential properties situated in its administrative area.”
