### FAQ for Students applying for Residential Permits.

Students are advised to email <u>ParkingPermits@corkcity.ie</u> with their full address including Eircode before changing documents to check eligibility of an address and to confirm how many current permits are active at this address.

Due to GDPR, we can only discuss an application with the individual making the application.

• **Do I need to change my address on my vehicle documents?** Yes, all applicants including students must have the address for which they are applying for a permit for on their vehicle documents; i.e the documents must match the applicants name and address they are applying under.

# • How to change Registration Address for Vehicle Log Book / Licencing Certificate

If the vehicle is not registered to the address, the Vehicle Registration Form must be submitted to the Vehicle Registration Unit in Shannon Co. Clare for change of address to where you are applying for the permit. Alternatively, you can submit your log book to Cork County Council, Motor Taxation Office who will arrange for the updated log book to be issued. Cork County Council will then issue a Vehicle Enquiry Form confirming that the change in address has been submitted and this can be submitted in lieu of the log book.

#### • I do not have a utility bill, what can I submit as proof of address?

We understand that students may not have a utility bill in their own name at their rented accommodation. We can accept bank or Revolut statements dated in the previous 3 months. We can also accept Revenue or Social welfare documents. All documents containing sensitive financial information should be suitably redacted by the applicant before their submission.

### • There are already 3 active permits at my address, can I still apply?

Unfortunately, if you are a new applicant we cannot accept a fourth permit application. With effect from 1st January 2027, a maximum number of three Residents Parking Permits will be allowed per qualifying residence in the subject area of Cork City Council Parking Byelaws 2016. In the interim period, commencing 1st May 2022 until 31st December 2026, Cork City Council will not accept new applications for a fourth permit for a qualifying residence.

# • My lease agreement is only dated 6 months; can I still get a permit for a full year?

To be eligible the lease period must be a minimum of 6 months or being a rolling lease. If the lease period is shorter than one year (and a minimum of 6 months), the parking permit will be issued for the period of the lease.
