Keen to avoid this fate for Ian his mother took him to Ireland to avoid conscription. He fell in love with the language, music and culture of the Nation and joined the struggle for freedom.

The Commemoration would provide an opportunity for Cork to potentially expand and build links with Scotland, Liverpool and Massachusetts (USA), through potential initiatives, invitations and friendship building.

In addition, it would provide a fitting tribute to 3 Volunteers, born outside of Ireland, but who gave the ultimate sacrifice for the freedom of Ireland.'
