### 1. Welcome

### 2. Minutes

#### a. Community Activities Fund

**Kieran O'Connell:** The Community Enhancement Programme 2022 funding has been closed with 314 applications. The next process will be assessing the applications in partnership with the HSE, ETB and Cork City Council Community Team.

### 4. SICAP Pobal Feedback Report

**Kieran O'Connell:** explained that the SICAP end of year review is all in line with what has been presented before. On par with all the programme targets and finance monitoring.

## 6. Strategic Items

### a. Sláintecare Healthy Communities/Healthy Ireland Fund

**Rebecca Loughry:** explained that Tanya O'Sullivan has started her new role and a Local Implementation Team must be put in place. A national PR campaign is to launch soon. The **€250,000** will be assessed by the ETB and SICAP.

Healthy Ireland announced another stream of funding and Minister Frank Feighan visit to Togher Community Garden.

### b. Cork City LECP

**Adrienne Rodgers:** explained there was an Interdepartmental review about the LCDC and its progress over the last 6 years. The feedback was that there was a lot of misinformation about how the LCDC fits into the community and how we need training for new LCDC members.

**Martha Halbert:** gave a presentation on the LECP Formulation.
