Ensure 24/7 security is maintained until CCTV is installed.

Survey the cemetery boundary wall to see if it can be raised to prevent unauthorised access.

Meet with the newly formed St. Catherine's Cemetery Kilcully Community Action Group to address their concerns and recommendations.

Support where possible the families affected by vandalism to the graves of loved ones.'

6. **QUESTION TIME**

6.1 HALF MOON PEDESTRIAN ACCESS TO TRAMORE VALLEY PARK

In response to the following question submitted by Comhairleoir M. Finn a written reply was circulated as outlined below:-

Can an update and full report be given at our first meeting of Council in 2020 as to the progress in the opening up of the Half Moon Lane pedestrian access point to Tramore Valley Park to include the factors involved in the process and any necessary reconfiguration works. Also to include details of the tree planting regime planned.

(Cllr. Mick Finn)

REPLY

Half moon Lane is a narrow lane off South Douglas Road serving Christ King Girls Secondary School, a number of commercial premises, ESB pitch & putt club, one residential property and a large City Council Depot accommodating Plant & Machinery, Cleansing and Traffic Departments. All these uses generate considerable vehicular

traffic ranging from large commercial vehicles to family saloons. The lane measures approximately 250 metres in length and ranges in width from 4m - 5.5m. There is no public footpath and no dedicated car park spaces along the lane. The junction with the South Douglas Road is not a controlled junction (no traffic lights) and is completely blind in both directions when exiting. In the context of the above, the lane is completely unsafe for pedestrians and cyclists using it to access Tramore Valley Park and considerable improvement works are required to bring it up to a safe standard. It is also important to note that providing an access to the park from Halfmoon Lane will also attract visitors arriving by car and, given that there is no dedicated parking area, cars are likely to be abandoned along the narrow lane creating a serious obstruction for other vehicles using the lane to access their premises and for parents dropping and collecting school children. Consultants will be appointed in the coming weeks to undertake a traffic assessment and survey of the lane and prepare draft improvement proposals to address the above issues.

This exercise will be followed by a part 8 application and, if approved, detailed design, tender and contract will follow. Total timescale is approximately twelve months.

Extensive tree and shrub planting has been undertaken throughout the park in recent years in line with the 2015 Landscape Proposals. The park due to its previous use as a Landfill has an extensive network of gas, leacheate, surface water and utility infrastructure and this restricts the areas that can be planted. Unplanted areas are being managed as wild flower meadows giving a balance to the park of areas with tree cover and wild flower meadow.

Perimeter hedgerow planting along the boundary with the South City Link will be undertaken this spring.

6.2 <u>TELECOMMUNICATION MASTS - HARBOUR VIEW ROAD & ARDCULLEN</u>

In response to the following question submitted by Comhairleoir T. Fitzgerald a written reply was circulated as outlined below:-

To ask the Chief Executive to publish a report relating to the installation of two columns on Harbour View Road, Knocknaheeny and Ardcullen, Hollyhill, stating the process and legal requirements for these masts, why local representatives the local community were not consulted and if there are other applications on file across the city?

REPLY

The Government's National Broadband Plan is a framework for the provision of high speed broadband through a combination of commercial and state investment. Cignal are a registered provider for the communications industry and is authorised by ComReg to provide electronic communications networks and services. This authorisation from ComReg allows Cignal to apply for licences for over ground electronic communications infrastructure.

Cignal provide tower, mast, rooftop and street work solutions for the expanding requirements of operators including EIR, Vodafone and Three. Cignal work closely with mobile operators to identify locations known as 'blackspots' for mobile and wireless broadband. It is on this basis that licence applications for street work solutions are made. These proposed sites/locations are areas where coverage for mobile phones and data devices is required.

As such, the location of street work solutions are proposed by the applicant/registered provider. These locations are then considered by the Planning Authority.

The licensing process for this over ground electronic communications infrastructure and any associated physical infrastructure' i.e. a street work solution is set out in Section 254 (1) (ee) of the Planning and Development.' In considering a licence under Section 254 for such infrastructure the Planning Authority in consultation with the Roads Operations Division of the Council must have regard to four considerations as prescribed by the Act:

- (a) the proper planning and sustainable development of the area,
- (b) any relevant provisions of the development plan, or a local area plan,
- (c) the number and location of existing appliances, apparatuses or structures on, under, over or along the public road, and,
- (d) the convenience and safety of road users including pedestrians.

A referral report is received on all files from the Roads Operations Division, and where appropriate from the Housing Capital and Regeneration Section of the Council. Unlike a planning application, there is no requirement for the applicant to put up a site notice of to place an ad in the newspaper. Moreover, the Section 254 licensing process does not provide for the consideration of third party submissions as part of the decision making process.

A licence may be granted by the Planning Authority for such period and upon such conditions as the authority may specify, including conditions in relation to location and design. Developments which are carried out in accordance with a licence are exempted development in accordance with Section 254(7) of the Planning and Development Act. This provision exempts this type of development, meaning that planning permission is not required.

Further to the initial licence, Section 101D of the Road Traffic Act relates to carrying out roadworks or works on the road inclusive of reinstatements and road opening licenses applies where necessary to the works when the poles are being installed.

To date; 16no applications have been made to the planning authority for a licence. A complete list of all applications received is attached as Appendix A of this response.

- 10 no. have been approved, which include repeat applications for revised locations and/or design.
- 3 no. applications have been refused.
- 2 no. application has been withdrawn, and
- 1 no. applications remain pending decision.

The applicant for all sixteen applications are Cignal Ltd. Cignal Ltd. carry out surveys of mobile phone blackspots and where these blackspots are noted they apply for a Section 254 license for provision of a telecommunications pole. It is on this basis the applications have been made for Harbour View Road, Knocknaheeny and Ardcullen, Hollyhill, together with a number of other site across the City. It is intended that this infrastructure is shared which could in fact reduce the number of installations required to provide mobile phone coverage across a number of operators.

Cignal are a registered provider for the communications industry and is authorised by ComReg to provide electronic communications networks and services. Can the Chief Executive & Council agree that no plastic bottles are provided at the 2020 mini marathon and marathon to emphasize our commitment to the single use plastic bottle reduction/exclusion as part of our Healthy City? An App should be provided to locate the installed Water Refill Stations in our parks and city?

(Cllr. Des Cahill)

REPLY

Irish Water is in the process of developing a policy in relation to drinking water points in public areas, and are in discussions with the Regulator as to how they should be progressed. Their installation in public areas is being investigated under a current Cork City Council Infrastructure project

Confirmation of a successful application to the Healthy Ireland Fund for 50% grant funding that would allow installation of 5 no drinking water fountains in our Parks has just been received, and this will be progressed in the coming months.

Cork City Marathon has been working with the Council's Environment Office for the last few years to gradually eliminate single-use plastic and waste from the event. We compost all organic waste at the finish line, provide reusable goody bags, have removed all plastic wrapping from medals and shirts, and engage Refill Ireland to provide filtered water in reusable tumblers at the finish line. Given the critical role of hydration, particularly in a summer race, we still provide plastic bottled water on the course, but aspire to eliminate all bottles from the race by 2021. Other event organisers will also be encouraged to follow similar practices.

In addition, one of the main water stations on the course in 2020 will be stocked with water-filled Oohos – seaweed-based compostable pouches that can be eaten or discarded to biodegrade within 4-6.

The City Council also received funding from the EPA's Local Authority Prevention Network in 2018 to promote Refill.ie at a local level in order to increase the number of Refill.ie members in Cork City and increase the awareness of Refill.ie amongst the general public.

The project was delivered by Cork City Council in partnership with Refill.ie and Cork Environmental Forum. Over the three month period, approximately 50 premises were visited and 28 premises signed up for the Refill.ie scheme. All of these businesses were issued with stickers to be displayed on their premises. In addition, each of the premises was added to the Refill.ie Tap Map. At present, there are over 60 premises in Cork City signed up to Refill.ie which means that they provide tap water refills to the general public free of charge.

In 2018, this site was placed on the derelict sites register. The owner has engaged with planning officials with a view to potential development of the site. Cork City Council is actively engaging with the owners with a view to developing the site.

6.8 SUPREME COURT DECISION IMPLICATION

In response to the following question submitted by Comhairleoir D. Boyle a written reply was circulated as outlined below:-

To ask the Chief Executive if she has considered the implications of the recent Supreme Court decision in Fagan v. Dublin City Council and whether Cork City Council operates a similar policy to Dublin City Council with respect to the treatment of separate fathers who are social housing applicants and do we know how many applicants may be impacted by this ruling and will it require a revision of our Social Housing Allocation Scheme?

(Cllr. Dan Boyle)

REPLY

The City Council has reviewed the recent Supreme Court decision in Fagan v Dublin City Council and has considered the implications of this judgement.

Cork City Council does not operate a similar policy to Dublin City Council in its assessment process for the social housing requirements of separated parents regarding access requirements for children. The City Council assesses each individual application for housing or housing support on its own merits.

The City Council Housing Directorate does not envisage any housing applications being affected or a change in allocation procedures in Cork City as the Council's procedures are broadly in line with the findings of the Judgement and a revision of the Allocation Scheme is not deemed to be necessary.

6.9 <u>ARCHAEOLOGICAL DIG – BESSBOROUGH GROUNDS</u>

In response to the following question submitted by Comhairleoir K. McCarthy a written reply was circulated as outlined below:-

To ask the CE for the City Council's role, if any, in the archaeological dig that recently took place on Bessborough grounds?

(Cllr. Kieran McCarthy)

REPLY

A programme of pre-development geophysical survey and archaeological test trenching was recommended by the City Archaeologist as part of pre-planning discussions in relation to a proposed development at this site. This is a standard recommendation given the size and scale of the proposed development and the sites location in close proximity to known archaeological Recorded Monuments and Places (RMP).

The site was examined by a geophysical surveyor and was deemed unsuitable for Ground Penetrating Radar (GPR) GPR requires a very even ground surface free from excess vegetation and modern debris.

A programme of archaeological test trenching commenced on Monday 9th December 2019. This work involved some necessary site clearance works. This work was carried out under archaeological licence issued by the National Monuments Service, Department of Culture, Heritage and the Gaeltacht. The trenches were excavated, under supervision by a suitably qualified and experienced archaeologist, with a machine with a toothless bucket. The soil was removed in spits and was subsequently sieved on site. This is considered best practice. The City Archaeologist was kept informed at all times and undertook a site inspection on Wednesday 11th December 2019.

The ground works ceased on the afternoon of Wednesday 11th December following discussions with the National Monuments Service and the developer's archaeologist. This was due to a technical issue with the archaeological licence.

No archaeological features or finds were noted in the trenches excavated.

Cork City Council is aware of the sensitivities associated with the site and this was also discussed with the representatives of the developer. The approach taken to the archaeological testing recognised the sensitivities of the site.

REPLY

Cork City Council parking enforcement increase patrols in the area of Páirc Uí Chaoimh during match days and events and AGS also carry out parking enforcement in the area.

Traffic management for events is coordinated between AGS, Cork City Council and other relevant stakeholders. Each event is reviewed at event planning meetings and a relevant traffic management plan is agreed with actions to implement on event days (i.e. vehicular routes, diversions at key junctions, road closures, pedestrian routes and emergency access). AGS coordinate this on event days.

'That in light of the recent damage to multiple graves and headstones at St. Catherine's cemetery, that Cork City Council would put in place enhanced security measures, including CCTV, to protect St. Catherine's cemetery, Kilcully.'

(Proposers: Cllr. J. Sheehan, Cllr T. Fitzgerald 20/004)

'Following recent attacks and serious vandalism on head stones and graves at St. Catherine's cemetery, Kilcully, that Cork City Council will respond to the widespread hurt, anger and concern by the families and the community by;

Installing CCTV and adequate lighting within the cemetery perimeter.

Ensure 24/7 security is maintained until CCTV is installed.

Survey the cemetery boundary wall to see if it can be raised to prevent unauthorised access.

Meet with the newly formed St. Catherine's Cemetery Kilcully Community Action Group to address their concerns and recommendations.

Support where possible the families affected by vandalism to the graves of loved ones.'

11.1.1 RESIDENTIAL PERMIT PARKING IN THE VICINITY OF THE DOCKLANDS

An Chomhairle considered and noted the report of the Director of Operations, dated 2nd December 2019 on the following motion referred to the Committee:-

'That, in order to prevent unwanted on-street parking in the vicinity of city and docklands developments with reduced or no parking provision, Cork City Council will (a) introduce residential permit parking for pre-existing residents on streets in the vicinity of these developments and (b) require the developer/management company of these developments to make contributions towards the implementation and on-going costs of the enforcement of parking regulations in the vicinity of these developments.'

(Proposer: Cllr. O. Moran 19/413)

The report of the Director of Operations stated that parking space is a scarce resource and balanced between the competing needs of residents, businesses, visitors, the disabled and public transport providers. Parking Management is controlled through a combination of pricing, time restrictions and enforcement to achieve a number of objectives:

- Maximise space turnover;
- Accommodate all-day commuters in the Park & Ride site
- Reflect the parking needs of residents within the Pay Parking Control Zone
- Reflect the need for Disabled Parking, Loading Bays and Taxi Ranks Maintaining the turnover of on street spaces to ensure optimum availability of parking in the city is one of the main aims of the enforcement regime.

To reflect the needs of residents within the Pay Parking Area, Cork City Council operates a Resident's Parking Permit Scheme as prescribed in Cork City Council Parking Bye-Laws 2016 and in accordance with the Residents Permit Policy of Cork City Council. A resident who is the owner of a vehicle and who lives in a pay parking area can apply to Cork City Council for a Parking Permit, which allows the vehicle to be parked without limitation as to time in a specified area to which the permit relates, and the application will be determined in accordance with the Bye-Laws and Policy. Public roads may not be allocated to or assigned for residential permit parking only.

Cork City Council has no power to request developers / management companies to contribute to the implementation and on-going maintenance costs of the enforcement of parking regulations.

11.1.2 REINSTATING ROADS AND FOOTPATHS AFTER WATER WORKS

An Chomhairle considered and noted the report of the Director of Operations, dated 2nd December 2019 on the following motion referred to the Committee:-

'That Cork City Council work in tandem with Irish Water and pool resources when reinstating the roads and footpaths after water works. We should also collaborate when reinstating road paintings and markings.'

(Proposer: Cllr. S. Martin 19/167)

The report of the Director of Operations stated that Irish Water are required by the conditions of their road opening licences to comply fully with the standards laid down in the 'Guidelines for the Managing Openings in Public Roads' published by the Dept of Transport, Tourism and Sport. This document outlines the requirements for temporary and permanent reinstatement of public roads and footpaths including road markings.

The discussions focused primarily on Ballincollig but also school provision in other areas of the city was also discussed. A number of options were reviewed and new prospective sites were outlined to the Department of Education and Skills.

It was agreed that the Department of Education and Skills would furnish Cork City Council with a list of areas with high demand for new schools and that both parties would meet on a regular basis to discuss same and appraise prospective sites.

In the interim Cork City Council will endeavour to identify additional suitable sites as part of the Development Plan preparation process.

13.1.2 **ZONING LAND FOR EDUCATIONAL USE**

An Chomhairle considered and noted the report of the Director of Services, Strategic and Economic Development dated 22nd November 2019 on the following motion referred to the Committee:-

'Given the extremely long waiting lists for ASD classes in local primary and secondary schools and the serious shortage of special schools in Cork, that Cork City Council ensure that, in the City Development Plan, a particular emphasis is placed on zoning land for educational use.'

(Proposer: Cllr. S. O'Callaghan19/511)

The report of the Director of Services stated that the provision of schools is an integral element of the social and community requirements of an area and the Planning Authority endeavours to make provision for schools as part of its land use planning policy.

A meeting between Cork City Council and representatives of the Department of Education took place on 14th November, 2019 in relation to the provision of new school sites in Cork City.

It was agreed that the Department of Education would furnish Cork City Council with a list of areas with high demand for new schools and that both parties would meet on a regular basis to discuss same and appraise prospective sites.

In the interim Cork City Council will endeavour to identify additional suitable sites as part of the Development Plan preparation process.

The reports of the Director of Services stated that the property at 58 MacCurtain Street is in the control of the Office of Public Works, having previously been used as a Garda Station. The property has not been in use for a number of years, and some reconfiguration and refurbishment will be required to bring the building back to active use. It is clear that substantial capital and revenue investment will be required. Previously, some private interest was expressed to develop the property for tourism purposes and the City Council engaged with the Office of Public Works in relation to same. The Property Department has again been in contact with the Office of Public Works requesting that the property would be brought forward for disposal to enable it to be brought back to active use. A further report will issue outlining any progress in this regard. (4th April 2019)

There is no further update. (8th October 2019)

Property has been sold, confirmed by Linsey's Auctioneers (10th December 2019).

21.1 **SAFETY OF 5G**

An Chomhairle considered and approved the following motion:-

'I am asking Cork City Council to conduct a detailed report into the safety of 5G. People are extremely worried and voicing their concerns about the harmful effects of radiation. Concerns must be addressed as there could be implications for the public. I call on this Council to support a report and alleviate the concerns of the public of this City.'

21.2 **BUS SERVICES**

An Chomhairle considered and approved the following motion:-

'That this Council request the manager of Bus Éireann, Cork to come to meet with City Councillors and executive to discuss all matters relating to bus services, in particular the 207, 216, digital alerts and other issues.'

21.3 **BROADBAND PROVISION**

An Chomhairle considered and approved the following motion:-

'Because the lack of fixed line broadband in various areas in Cork remains an issue of concern and frustration for residents, it is now over THREE years since this issue was raised with Eir and as yet we are no closer to having broadband installed. I call on City Council to urgently bring senior representatives of EIR in to discuss the issue with Councillors to clarify and update us on the situation.19546

The fact that broadband is supplied in other apartments and estates in the area only further exasperates the situation.

Fibre optic cables are in place but as of now have not been activated despite countless requests to Eir/OpenEir/KN Networks to do so.'

21.5 CALL ON GOVERNMENT TO REVERSE RETIREMENT AGE

An Chomhairle considered and approved the following motion:-

'That Cork City Council call on the Government to reverse the retirement age from 66 years back to 65 years. Forcing 65 year old people on to a jobseekers payment for one year before accessing their State Pension at 66 years is wrong and from next year the retirement age will increase to 67 years and this should also be stopped.'

21.6 **NORTHERN RING ROAD**
