2. Confirmation of minutes of previous meeting - Proposed by Cllr Damian Boylan, seconded by Cllr Joe Kavanagh.

<p>4. Presentation by Supt. John Deasy: Topics included Cork Crime Statistics and trends compared to National Statistics/trends; High Visibility Policing Plan including High Visibility Beats (see presentation slides sent via email). An observation from Supt Deasy for Crime Prevention was for the public to ensure their cars are locked. Supt Finbarr O'Sullivan added to report financial fraud immediately to the bank and then to the Gardai.</p> <p>Chair Cllr Shannon thanked Supt. Deasy and opened the floor for Questions/Comments</p> <p>Q. Laura O Connell: Will this report be delivered quarterly?</p> <p>A. It can if members request it. All information is however available on the CSO website.</p> <p>C. Denis Leamy: Highlighted a recent piece of collaborative work where the CETB along with Citizen's Advice delivered training on Financial Literacy. He suggested this could be done in the future for other public awareness education/information campaigns.</p> <p>Q. Cllr Tony Fitzgerald: Will Community Gardai be redirected into the new High Visibility Policing staffing? Cllr Fitzgerald also highlighted the value of community policing at a suburban/neighbourhood level and reiterated the need to return to that model. Cllr Fitzgerald also enquired if the High Visibility Policing programme Gardai will have a referral pathway model to ensure those with needs such as mental health, addiction, homelessness, etc are signposted to other, non-policing services?</p> <p>A. Supt stated that all Gardai are Community Gardai and part of their duty is to be involved in the High Visibility Policing programme and at times are needed in the City Centre over the Christmas period also. There was a discussion on the need for collaboration on responding to, for example, mental health calls.</p> <p>C. Joe Kirby: Offered to work with Gardai on responding and referring in cases of mental health issues.</p> <p>C. Conor O Toole: HVPP approach should be applauded.</p> <p>C. Cliona Barnes: CBA will be issuing press releases on Wednesday 3rd Dec on the positives of HVPP and new City Centre Wardens.</p> <p>Q. Laura O'Connell asked about trends related to stalking and hate crime.</p>	

Q. Fiona Hurley: NASC hearing about more hate speech and hate crime from their clients who oftentimes are too scared or unsure how to report.

A. Supt Deasy agreed stalking and hate crime stats are often 'hidden' or grouped into broader categories but he offered to provide any specific stats for the next meeting if requested.

C. Cllr Damian Boylan: anxious that the LCSP helps Gardaí and asked Supt Deasy and O'Sullivan how the LCSP can support their service delivery. Supt's agreed to consider this ahead of the next meeting.

C. Chair Cllr Terry Shannon: pointed out the recent retirement of Chief Supt. Tom Myers, suggested a letter be sent from LCSP.
