3.1 ST. PATRICK'S DAY PARADE

An tArdmhéara advised An Chomhairle that in the context of the evolving circumstances of the Covid-19 virus, and following a risk assessment, based on WHO guidelines, An tArdmhéara and the Chief Executive had made a decision to cancel this year's parade.

3.2 COMMEMORATION EVENT 19th MARCH

An tArdmhéara advised An Chomhairle that invitations will be issued to An Chomhairle to attend a Commemorative Mass and wreath laying in Blackpool Church on the 19th March 2020.

The event will commemorate the murder of Tomás MacCurtain and will be attended by An t-Uachtarán, Michael D. Higgins.

3.3 <u>CITY DEVELOPMENT PLAN</u>

An tArdmhéara advised that there will be a briefing for An Chomhairle in relation to the City Development Plan on the 23rd March 2020 at 4.30pm.

3.4 **RENAMING OF ANGLESEA STREET**

An tArdmhéara advised that as part of the 1920 Commemorations it was intended to rename Anglesea Street. A public engagement process has been agreed, similar to that adopted for the naming of the Mary Elmes Bridge.

4. <u>CHIEF EXECUTIVE'S ITEMS</u>

4.1 **PROPOSED HOLDING OF AN EVENT**

McCarthy, An Chomhairle considered and approved the report of the Chief Executive dated 5th March on the proposed holding of an event by Cork City Council under the Planning and Development Act, 2000 and Planning and Development Regulations 2001. The event being the Seafest Maritime Festival 2020 to be hosted at the Port of Cork and Cork City Quays on the 15th, 16th, and 17th May 2020.

4.2 <u>CORK CITY COUNCIL'S PREPAREDNESS TO RESPOND TO THE</u> <u>COVID-19 VIRUS</u>

The Chief Executive gave An Chomhairle an update on the measures being taken by Cork City Council to ensure preparedness to respond to the evolving circumstances of the Covid-19 virus.

6. **QUESTION TIME**

6.1 INNISCARRA ROAD -PROPOSED PEDESTRIAN CROSSING

In response to the following question submitted by Comhairleoir C. Finn a written reply was circulated as outlined below:-

Can the Inniscarra Road be assessed for pedestrian crossings or have the Council any plans to improve pedestrian access to the Ballincollig Regional Park along this route?

(Cllr. Colette Finn)

REPLY

Presently access from the area in the vicinity of Westcourt Estate to the Ballincollig Regional Park is via a pedestrian bridge on the south-west corner of the park or via the carpark on the western side of the park, on Inniscarra Road. The entrance to Westcourt Estate is approximately 350m from the pedestrian bridge park entrance. The provision of additional new pedestrian access point directly to the Ballincollig Regional Park in the vicinity of Westcourt Estate would require a significant engineering project. Constraints in the area that would need to be considered include the breaking an entrance through the existing stone wall, the challenging topography in the area and the presence of a stream/river inside the stone wall that would require a bridge to be provided as part of the solution. The level of funding required for such an extensive project is not currently available and it could be argued is not justifiable given the fact that the existing park entrance is only 350m from the housing estate entrance.

Inniscarra Road can be assessed to determine the appropriateness for a pedestrian crossing in the vicinity of Westcourt, however there are topographical challenges in the area and currently there is no funding available for the installation of pedestrian crossing facilities. Any works deemed appropriate will be added for consideration in future roads programme and undertaken subject to available resources.

6.2 **PUBLIC HOUSING CONSTRUCTION AT MODEL FARM ROAD**

In response to the following question submitted by Comhairleoir T. Tynan a written reply was circulated as outlined below:-

To ask the CE for an update with regard to the 4.7 acre site at Model Farm Road and my motion 19/027 of which an amended version was agreed by Council on 14/01/2019 for referral to the Housing Functional Committee. Can the Chief Executive confirm if the Minister for Housing, Eoghan Murphy was written to and, if so, what response was received and if there has been any further update with regard to my proposal for the construction of 100% public mixed income housing on this site?

REPLY

The lands referred to at Model Farm Road are now within the functional area of Cork City Council and are not zoned as residential under the Development Plan.

The first stage consultation of issues to be considered in the new City Development Plan is due to formally commence in April 2020 and the Council's strategic objectives for the site will be considered in the context of that review. The Elected Members will be kept informed at all stages as the review progresses. Cork City Council has been in contact with the Department of Housing, Planning & Local Government and it has been confirmed that it will consider the Council's proposals for a development of housing on the site as per normal procedures once an appropriate zoning is in place for residential development

Where are we at with Cork City Council drawing up the legal documents with Nemo Rangers to take over the ownership of the Tramore River as agreed by previous Councils?

REPLY

The property section are currently finalising the mapping of the site which should be complete imminently. Once this is complete, the necessary legal process can be concluded with Nemo Rangers.

6.4 <u>PEDESTRIAN ACCESS FOR TRAMORE VALLEY PARK AT HALF</u> <u>MOON LANE</u>

In response to the following question submitted by Comhairleoir D. Boyle a written reply was circulated as outlined below:-

To ask the Chief Executive to provide any legal basis for concerns that has delayed the opening of a pedestrian access for Tramore Valley Park at Half Moon Lane.

(Cllr. Dan Boyle)

REPLY

The legal basis is one of safety for existing users of Half Moon Lane and those who would use it to access the park.

Half moon Lane, is a narrow lane off South Douglas Road serving Christ King Girls Secondary School, a number of commercial premises, ESB pitch & putt club, one residential property and a large City Council Depot accommodating Plant & Machinery, Cleansing and Traffic Departments. All these uses generate considerable vehicular traffic ranging from large commercial vehicles to family saloons.

The lane measures approximately 250 metres in length and ranges in width from 4m - 5.5m. There is no public footpath and no dedicated car parking spaces along the lane. The junction with the South Douglas Road is not a controlled junction (no traffic lights) and is completely blind in both directions when exiting.

In the context of the above, the lane is completely unsafe for pedestrians and cyclists using it to access the Park and considerable improvement works will be necessary to bring it up to a safe standard. It is also important to note that providing an access to the park from Half Moon Lane will attract visitors to the park arriving by car and, given that there is no dedicated parking area, cars are likely to be abandoned along the narrow lane creating a serious obstruction for other vehicles using the lane to access their premises and, for parents dropping and collecting school children.

A traffic assessment and, survey of the lane is due to commence shortly and draft improvement proposals should be ready for consideration by early May. Should it be feasible to provide a safe access to the park along the lane, a part 8 application will be submitted to the South East LAC and Council for consideration. If approved, detailed design, tender and contract will follow.

Total timescale from survey to implementation will be approximately twelve months, but this timeline is subject to the required capital funding being secured to deliver the project.

6.5 **EROSION OF BANK - ST. GERARD'S PLACE**

What are the results of the OPW study of possible erosion of the bank behind the houses St. Gerard's Place and Island View and what is the result of the examination of same area by Council officials and what action can or should be taken to rectify the surface deterioration due to the undermining of the bank which may have deteriorated due to storms.

REPLY

Cork City Council is unaware of the OPW having carried out a survey at this location. Will follow up with the OPW and the Department of Food, Agriculture and the Marine to ascertain if same exists.

We are also following up with the County Council to see if they have any information on this matter. Once this has been done we will revert.

Following on from a site inspection I can confirm that while the road is in poor condition there is no evidence of road subsidence.

To ask the Chief Executive to provide a full list of Council owned property that fulfils the criteria for inclusion on Cork City Council's derelict sites register and to provide a narrative as to why some Council owned property does not appear to be included on the public facing register?

REPLY

Property Services are undertaking a review of the Core Portfolio of Properties which are in CCC ownership; and as part of that process all built assets will be considered in terms of condition. If any building is considered to be in a derelict condition it will be classified as such. It is anticipated that this schedule of derelict property would be for internal use as Property Services works with the other departments on removing dereliction with the portfolio.

Stephen Fox from Property Services would be happy to meet with you to discuss any particular properties which are of concern.

6.7 **VACANT COUNCIL PROPERTIES**

In response to the following question submitted by Comhairleoir M. Finn a written reply was circulated as outlined below:-

Can the CE outline how many Council owned properties are currently boarded up or not in use (ie voids) and if it is possible to determine via the HSE how many are in the Fair Deal Scheme in the city and currently vacant?

(Cllr. Mick Finn)

REPLY

A total of 341 units of the City Council's social housing stock are in transition between tenancies of which, 102 units are currently under offer and awaiting tenancy and the remainder are at various stages of pre-tenancy repair. As per policy, many of these housing units have to be boarded up to protect valuable built assets from anti-social behaviour.

The Health Service Executive (HSE) is best placed to answer queries regarding the Fair Deal Scheme.

However, it should be noted that there are no Council houses "*in the Fair Deal Scheme*". The amount recipients of this assistance are required to contribute towards their care is calculated on the basis of their income and assets. Although an individual's contribution can be deferred by way of a loan, the asset does not belong to or come under the control of the HSE.

REPLY

Updated inspection reports are required to itemise the outstanding works in relation to the various infrastructure elements to establish an estimated cost of the necessary works to complete the development to taking in charge standard. This is subject to adequate resources being made available to carry out these reports. Please note that Cork County Council claimed the bond for this development, in the amount of \notin 56,878, however, to date, following multiple requests Cork City Council are not in receipt of this bond. A recommendation to take the estate in charge cannot be made until the works are completed

The Tender clarification process with the Most Economic Advantageous Tenderer is near completion. Should the Council be satisfied with all clarifications sought, it is anticipated a contract for the works will be issued in the coming weeks.

REPLY

The question requests my personal opinion in relation to the reform / change of local government and does not relate specifically to the business of Council as required by Standing Orders.

The reform / change of Local Government is a matter for the National Legislature. My role, as Chief Executive is to operate within the existing legislative framework and not to individually advocate for it's reform/change. I would be happy to engage

through appropriate representative structures in any consultative processes in relation to any proposals of Government for reform/change, and to support the Members if required in their consideration of any such proposals.

6.11 **PARTIAL COLLAPSE OF HOUSE ON CHURCH AVENUE**

In response to the following question submitted by Comhairleoir M. Nugent a written reply was circulated as outlined below:-

Can the CE report on a partial collapse of a house on Church Avenue off Roman Street recently which has also affected neighbouring properties? What was the response of the City Council to the incident and any follow up as residents in the area remain very concerned?

REPLY

Cork City Fire Brigade responded to an incident involving the partial collapse of a rear garden retaining wall at 9 Church Avenue on 20/02/2020 at 20.35hrs. At the time as a precautionary measure people were evacuated from their houses in the vicinity of the collapse. This included properties on Church Avenue, Easons Hill and Upper John Street.

Cork City Council Traffic Department also attended the incident.

Cork City Fire Brigade attended a further call with regards to back garden subsidence on 22/02/2020 at 12.13hrs at 7 Church Avenue.

Cork City Council investigated the partial collapse of this retaining wall under the Local Government (Sanitary Services Act) 1964, and are satisfied that this is a civil matter between private property owners .

Cork City Council has written to each property owner concerned and recommended that they

seek independent Structural Engineering and Legal opinion on the matter as soon as possible.

6.12 **<u>BIKE SCHEME</u>**

In response to the following question submitted by Comhairleoir H. Cremin a written reply was circulated as outlined below:-

To ask the Chief Executive to outline what reforms/changes to the powers or operation of local government she believes are most necessary or would be most beneficial for Cork City Council to deliver on Cork's potential as Ireland's second city in the coming decade?

(Cllr. Henry Cremin)

REPLY

Under the current Public Bike Scheme there are approximately 330 bicycles available for hire from 31 docking stations across the City. The docking stations are spread over an area from Kent Station through the City Centre to UCC. The scheme has proven to be very popular and there are currently in excess of 14,000 registered users with 270,000 trips per annum.

In response to Council requests, the National Transport Authority (NTA) has confirmed its willingness to support an expansion of the scheme. It is expected that such an expansion will operate as an extension to the existing network of docking stations and provide further connections to destinations in the west of the City. The City Council is currently engaging with the NTA in relation to progressing such an extension and the necessary financial supports. Details of same will be confirmed to Council as they become available.

A total of 1307 litter fines were issued in 2019 broken down as follows:

6.14 COMMUNICATIONS MAST

In response to the following question submitted by Comhairleoir T. Shannon a written reply was circulated as outlined below:-

To ask the CE to report to City Council on the circumstances surrounding the erection of a communications mast at the junction of Boreenmanna Road and Victoria Avenue a number of weeks ago?

What role, if any, does Cork City Council have in this process? Is planning required or was this work carried out under a licence? What, if any, public consultation took place regarding this work? Are there any health and safety issues associated with this work? What is the purpose of this mast? Is there a time span for a review of this piece of infrastructure?

REPLY

What role, if any, does Cork City Council have in this process?

The Government's National Broadband Plan is a framework for the provision of high speed broadband through a combination of commercial and state investment. Cignal are a registered provider for the communications industry and is authorised by ComReg to provide electronic communications networks and services. This authorisation from ComReg allows Cignal to apply for licences for over ground electronic communications infrastructure

The location of streetwork solutions are proposed by the applicant/registered provider. These locations are then considered by the Planning Authority

Is planning required or was this work carried out under a licence?

The licensing process for this overground electronic communications infrastructure and any associated physical infrastructure' i.e. a streetwork solution is set out in Section 254 (1) (ee) of the Planning and Development.' In considering a licence under Section 254 for such infrastructure the Planning Authority in consultation with the Roads Operations Division of the Council must have regard to four considerations as prescribed by the Act:

(a) the proper planning and sustainable development of the area,

(b) any relevant provisions of the development plan, or a local area plan,

(c) the number and location of existing appliances, apparatuses or structures on, under, over or along the public road, and,

(d) the convenience and safety of road users including pedestrians.

What, if any, public consultation took place regarding this work?

A referral report is received on all files from the Roads Operations Division, and where appropriate from the Housing Capital and Regeneration Section of the Council. Unlike a planning application, there is no requirement for the applicant to put up a site notice or to place an ad in the newspaper. Moreover, the Section 254 licensing process does not provide for the consideration of third party submissions as part of the decision making process.

In this case, the Roads Operations Division of Cork City Council submitted their report stating there was no roads related reason to refuse the application and outlined a number of conditions to be attached to the licence.

Are there any health and safety issues associated with this work?

Guidance on the process has been published by the Department of Communications, Energy and Natural Resources, and is available for review at the following link: <u>https://www.dccae.gov.ie/en-ie/communications/publications/Pages/Guidance-on-the-Potential-Location-of-Overground-Telecommunications-Infrastructure-on-Public-Roads.aspx*.</u>

*It should be noted that there is a discrepancy in the Guidelines which states that Class 31 of the Planning and Development Regulations allows for exempted development outside of public roads for poles or support structures up to 10 meters in height. Class 31 in fact allows for a height of up to 12 meters.

What is the purpose of this mast?

Cignal provide tower, mast, rooftop and **streetwork solutions** for the expanding requirements of operators including EIR, Vodafone and Three. Cignal work closely

with mobile operators to identify locations known as 'blackspots' for mobile and wireless broadband. It is on this basis that licence applications for streetwork solutions are made. These proposed sites/locations are areas where coverage for mobile phones and data devices is required.

Is there a time span for a review of this piece of infrastructure?

A licence may be granted by the Planning Authority for such period and upon such conditions as the authority may specify, including conditions in relation to location and design. **Developments which are carried out in accordance with a licence are exempted development** in accordance with Section 254(7) of the Planning and Development Act. This provision exempts this type of development, meaning that planning permission is not required.

Further to the initial licence, Section 101D of the Road Traffic Act relates to carrying out roadworks or works on the road inclusive of reinstatements and road opening licenses applies where necessary to the works when the poles are being installed.

7.1 <u>CAPITAL ASSISTANCE SCHEME: COPPERGATE, 8 ANGLESEA</u> <u>TERRACE, CORK - GALTAN CLG</u>

An Chomhairle considered and approved the report of the Acting Director of Services, Housing Directorate dated 20th February, 2020 in relation to a loan facility for Galtan CLG in respect of the provision of four one bedroom units of accommodation at Coppergate, 8 Anglesea Terrace, Cork.

On the proposal of Comhairleoir F. Dennehy, seconded by Comhairleoir K. McCarthy, An Chomhairle further agreed to adopt the following Resolution:-

"Resolved that, pursuant to the provision of Section 6 of the Housing (Miscellaneous Provisions) Act, 1992, a loan facility not exceeding $\in 600,000$ be granted to Galtan CLG, subject to the terms of the Capital Assistance Scheme for the provision of four one bedroom units at Coppergate, 8 Anglesea Terrace, Cork".

7.2 <u>CAPITAL ASSISTANCE SCHEME: 53, KNAPPS SQUARE, MULGRAVE</u> <u>ROAD, CORK - FOCUS HOUSING ASSOCIATION CLG</u>

An Chomhairle considered and approved the report of the Acting Director of Services, Housing Directorate dated 20th February, 2020 in relation to a loan facility for Focus Housing Association CLG in respect of the provision of a one bedroom apartment at 53, Knapps Square, Mulgrave Road, Cork.

Cork City of Sanctuary is not a programme of Cork City Council, rather an independent movement which works in close dialogue and co-operation with the Council, as well as other stakeholders from across the city. The movement is led by a capable and experienced Steering Group. This group held a strategy and planning session in November 2019 which reflected on progress to date and looked ahead to planning and priorities for 2020.

A meeting is planned this month between representatives of the Steering Group and the Community Team, to look forward to shared priorities and opportunities in the coming year.

'That Cork City Council will classify illegal parking as anti-social behaviour and adopt a zero tolerance policy towards illegal parking on double yellow lines, bus lanes, cycle lanes and footpaths, including the employment of additional and weekend parking enforcement staff funded through increased revenue from fines issued through a zero tolerance approach.

(Proposer: Cllr. O. Moran 19/482)

The report stated that parking on public roads is governed by the Roads Traffic Acts, the Road Traffic Regulations and parking byelaws as adopted by Cork City Council. Parking enforcement in respect of illegal parking is undertaken by An Garda Siochana and Cork City Council. In accordance with the governing legislation the system deployed by Cork City Council is based on Fixed Charged Penalty Notices (FCPN) issued by Traffic Wardens and this system operates six days a week, Monday to Saturday. Any expansion of this service would require resources to be provided in the Budget. The legislation does not allow the classification of this type of offence as anti-social behaviour but provides the driver of the vehicle is guilty of an offence and if the FCPN remains unpaid can lead to a court conviction. Any illegal parking will be issued with an FCPN once observed. Year to date 35,056 FCPNs have been issued for many offences including parking on double yellow lines, bus lanes, cycle lanes and footpaths.

12.7.2 ACCESS TO EMERGENCY VEHICLES

An Chomhairle considered and approved the report of the Director of Operations, dated 2nd December 2019 on the following motion referred to the Committee:-

'That City Council would put in place measures that would give access to emergency vehicles on all our public walkways across our city.'

(Proposer: Cllr. H. Cremin 19/507)

The report stated that appropriate barriers/bollards are erected at the entry points to amenity walks/cycle ways to prevent these areas being used by vehicular traffic with the obvious consequences for public health and safety. Prior to the installation of these barriers, these walk/cycle ways were being used as short cuts, for joy riding along with numerous incidents of burnt-out vehicles.

Fire service vehicles are equipped to push these barriers aside should they need to gain access.

An Chomhairle considered and approved the following motion:-

'That Cork City Council call on the NRA to restore the Tivoli dual carriageway from Silversprings to the Glanmire roundabout.'

27.2 <u>UPDATE WATER MAINS AT OLD MALLOW ROAD, MONARD,</u> <u>WHITESCROSS AND RATHPEACON</u>

An Chomhairle considered and approved the following motion:-

'That Cork City Council calls upon Irish Water to update the old water mains in the Old Mallow Road, Monard, Whitescross, Rathpeacon due to the continuous burst water mains, averaging 3 - 4 times per month in the area and the shortage of water to our citizens on a regular basis.'

27.3 **<u>RIGHTS OF PEOPLE WITH DISABILITIES</u>**

An Chomhairle considered and approved the following motion:-

'That Cork City Council support disabled people to have the right to Personal Assistance Service allowing disabled people to have freedom, choice and control over all aspects of their lives and can fully participate in an inclusive society as equals.

Considering the unanimous motion passed in Dáil Eireann on the 19th November 2019, and in March 2018 Ireland formally ratified the UN Convention on the Rights of People with Disabilities (UNCRPD), which under Article 19 states that disabled people have the right to live in the community and have access to a range of in-home and other supports including Personal Assistance Services (PAS) to support this.

Cork City Council recognises its obligation to consult closely with disabled people and their representative organisations in policy development as enshrined in Article 4.3 of the UNCRPD which states that "in the development and implementation of legislation and policies states parties shall closely consult with and actively involve persons with disabilities, including children with disabilities, through their representative organisations", specifically in relation to services provided by this Local Authority which impact on disabled people's lives, such as planning, housing, transport, social inclusion and enterprise.'

27.4 STUDENT ACCOMMODATION RENTS

An Chomhairle considered and approved the following motion:-

'Cork City Council stands with UCC Student Union in their fight against plans by to hike student accommodation rents and calls on UCC President, Patrick O' Shea to abandon the plan. Rents have been hiked by 19% in 3 years across five student centers and affordability must be the basis of student accommodation, not profit.'

27.5 HEALTH AND SAFETY CONCERNS OF STRYKER WORKERS

Council commends the 'Union Made is Stronger' campaign which is advocating on behalf of the workers.'

27.6 SECURITY AT ST. MARY'S HEALTH CAMPUS, GURRANABRAHER

'That Cork City Council write to the management of St. Mary's Health Campus, Gurranabraher requesting that security on the campus be reviewed in light of several incidents of anti-social behaviour affecting residents on Harbour View Road, Monastery Hill and other areas occurring following access from campus grounds.
